PREFATORY STATEMENT

The Municipal Health Office (MHO) of the Local Government Unit of Siayan is in need of permanent ambulance driver to carry patients to the hospitals for medical treatment.

The present ambulance driver in the person of Mr. Joseph I. Abad is only detailed to the Municipal Health Office (MHO) which his official position is under the Mayor's Office as reflected in the Plantilla of Personnel of the LGU. To augment the existing manpower of the MHO and in the interest of a more efficient and effective health services, there is a necessity of position of driver in the said office.

Thus, Administrative Aide IV, (Driver II), SG 4/7 Position occupied by Mr. Joseph I. Abad under the Mayor's Office be transferred to the Municipal Health Office (MHO) including its appropriation in the Plantilla of Personnel effective upon approval.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled, that:

SECTION I. TITLE: This Ordinance shall be known as "AN ORDINANCE EFFECTING THE TRANSFER OF THE POSITION OF ADMINISTRATIVE IV (DRIVER II), SG 4/7, ITEM # 1011-5 OCCUPIED BY MR. JOSEPH I. ABAD INCLUDING ITS APPROPRIATION IN THE PLANTILLA OF PERSONNEL UNDER MAYOR'S OFFICE TO THE OFFICE OF THE MUNICIPAL HEALTH OFFICER EFFECTIVE UPON APPROVAL".

SECTION II. ORDAINING CLAUSE: That Position of Administrative Aide IV, (Driver II), SG 4/7 with Item #1011-5 occupied by Mr. Joseph I. Abad including its appropriations in the Plantilla of Personnel under the Mayor's Office is hereby transferred to the Municipal Health Office effective upon approval.
