**"MUNICIPAL ORDINANCE NO. 17-05  
Series of 2017**

**AN ORDINANCE PROMULGATING RULES AND REGULATIONS ON THE LGU OWNED WEIGHING SCALES ACCREDITED BY THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) AND PRESCRIBING ITS DAILY RENTAL RATE DURING THE BUYING DAY AT DESIGNATED RUBBER BUYING STATION OF SIAYAN, ZAMBOANGA DEL NORTE.**

**BE IT ORDAINED**, by the honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in a session assembled;

**SECTION 1. The rules and regulations on the Use of Weighing Scales** - There is hereby promulgated Rules and Regulations on the use of the LGU owned Weighing scales accredited by the DTI for rent during the buying day of all designated rubber buying station this municipality, Siayan, Zamboanga del Norte.

- 1.1 Only the calibrated weighing scales owned by the Municipal Government and accredited by the DTI of Siayan, Zamboanga Del Norte shall be used in the weighing of RUBBER products sold at different designated buying station.
- 1.2 It shall be the duty of the Municipal Treasurer with the assistance of the recognized Rubber Canvassers for the proper installations in the area of the weighing scales intended for the weighing of Rubber products to be sold at the designated rubber buying station scheduled every end of the month.
- 1.3 Every Rubber Brokers/Buyers who gained entrance inside the Municipal designated rubber buying station, and are engaged in the business of buying rubber products are required to pay rental of the weighing Scale to be used in weighing the rubber products they are going to buy.
- 1.4 Each of the LGU owned Weighing Scales accredited by the DTI shall be use by the rubber broker/buyers on a rental basis, and to be paid in advance whenever they gain entrance at the Municipal designated Rubber Buying Station.
- 1.5 Rubber Brokers/Buyers are prohibited to use their own Weighing Scales in the conduct of buying of rubber products at any designated rubber buying station.
- 1.6 The Personnel of the rubber brokers/buyers in-charge in the weighing shall be assisted by the recognized Rubber canvassers and owner of the rubber products themselves, to ensure fair weighing and to prevent the manipulations of the true weight of the products, and the deceitful acts anomaly employed by the weigher.

- 1.7 Care and maintenance of the weighing scales shall be the sole responsibilities of the personnel of the office of the Municipal Treasurer, this agency.

**Section 2. The Rental Rate of the Weighing Scale:** The rental rate on each use of the LGU owned weighing scales in the conduct of buying of Rubber Products, inside the Municipal rubber buying station is hereby fixed at **Php 200.00** regardless of the volume of rubber products bought by each Rubber broker/buyer on that particular buying day.

**Section 3. Prohibition:** Rubber brokers/buyers who fail to pay the rental of the weighing scale in advance shall be denied and not allowed to enter in the designated buying station. This prohibition includes rubber canvassers who are not a License holder, to gain entrance at the designated rubber buying station.

**Section 4. Applicability Clause:** This ordinance shall form part of the Municipal Revenue Code of this municipality.

**Section 5. Effectivity Clause:** This ordinance shall take effect immediately after its approval.


Under other matters, it was agreed that next regular session will be on May 8, 2017 moved by Hon. Oliver A. Romero, unanimously seconded.


