Series of 2017**

**PREFATORY STATEMENT**

WHEREAS, Section 12 of Republic Act 10121 states that there shall be an established Local Disaster Risk Reduction and Management Office (LDRRMO) in every province, city and municipality, which shall be responsible for setting the directions, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction.

WHEREAS, the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte acted Municipal Ordinance No. 17-04, Series of 2017, dated March 13, 2017 "AN ORDINANCE CREATING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO) AS A SEPARATE AND DISTINCT DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, PROVINCE OF ZAMBOANGA DEL NORTE THE SAME TIME CREATING THE POSITION OF MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER, MUNICIPAL GOVERNMENT DEPARTMENT HEAD I, SALARY GRADE 24 AS THE HEAD OF SAID OFFICE PURSUANT TO REPUBLIC ACT NO. 10121 ALSO KNOWN AS THE PHILIPPINES DISASTER RISK REDUCTION AND MANAGEMENT ACT OF 2010 AND PROVIDING FUND THEREOF".

WHEREAS, Section 5 par (a & b) of Municipal Ordinance No. 17-04, Series of 2017 – specified:  
a) *Organizational Structure and Staffing Pattern of the Local Disaster Risk Reduction Management*  
composed of Twenty Two position items and par (b) *the funding requirements of the department shall be effected on a staggered basis depending on availability of funds and or the personnel services limitation requirements as well as other laws and guidelines governing creation of positions.*

WHEREAS, the Local Government Unit shall provide funds for One (1) item specifically the Local Disaster Risk Reduction Management Officer III, Salary Grade 18 under the Administration and Training, however subject to PS limitations prescribed under Section 325 of R.A. 7160, and said item shall be included in the plantilla of personnel CY 2018 of the Local Government Unit of Siayan, Zamboanga del Norte.

**BE IT ORDAINED** by the Honorable Sangguniang Bayan in session assembled, that:


**SECTION I. TITLE:** This Ordinance shall be known as "AN ORDINANCE APPROPRIATING FUNDS EQUIVALENT TO THE SALARY AND OTHER EMOLUMENTS OF THE LOCAL DISASTER RISK REDUCTION MANAGEMENT OFFICER III (LDRRMO III), SALARY GRADE 18, STEP 1, AND SHALL BE INCLUDED IN THE PLANTILLA OF PERSONNEL CY 2018 OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".


**SECTION II.ORDAINING CLAUSE:** That appropriation for the Position of Local Disaster Risk Reduction Management Officer III, (LDRRMO III) SG 18/1 is hereby provided effective Budget Year 2018, however subject to PS limitation prescribed under Section 325 of Republic Act 7160.

**SECTION III. EFFECTIVITY CLAUSE:** That this Ordinance shall take effect on January 1, 2018.


