"MUNICIPAL ORDINANCE No. 17-10
Series of 2017

AN ORDINANCE FOR THE CLOSURE OF EXISTING CONTROLLED DUMP SITE AT THE DESIGNATED AREA
FOR THE DISPOSAL OF SOLID WASTE MATERIALS OF LGU-OWNED LOT LOCATED AT BARANGAY
MUÑOZ, SIAYAN, ZAMBOANGA DEL NORTE;

Be it ordained by the Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled, that:

SECTION 1. Any person or group of persons are hereby prohibited to dispose their SOLID WASTE MATERIALS, such as agricultural wastes, yard wastes, bulky wastes, special wastes in the existing controlled dump situated at the designated area for the disposal of solid waste materials of five (5) hectare lot of the LGU of Siayan in Barangay Muñoz, Siayan, Zamboanga del Norte.

SECTION 2. DEFINITION OF TERMS:

- a. Person or group of persons – shall refer to any human being, natural or juridical, susceptible of rights and obligations or being the subject of legal relations;
- b. Solid Wastes – shall refer to all discarded household wastes, commercial wastes, institutional wastes that are non-hazardous / non-toxic wastes, such as street sweepings, construction debris, agricultural wastes, and other non-hazardous/non-toxic solid waste materials;
- c. Agricultural Wastes – shall refer to wastes generated from planting or harvesting of crops, trimming or pruning of plants, and solid waste materials from farms or fields;
- d. Bulky Wastes – shall refer to solid waste materials which cannot be appropriately placed in separate containers because of its bulky size, shape or other physical attributes. These include large worn-out or broken household items, commercial items, institutional items, industrial items, such as furniture, lamps, bookcases, filing cabinets, household appliances such as stoves, refrigerators, and other similar items;
- e. Yard Wastes – shall refer to wood small or chipped branches, leaves, grass clippings, garden wastes and vegetable residues;
- f. Special Wastes – shall refer to waste materials generated from households, commercial, institutional or industrial, that are hazardous and toxic which because of its quantity, concentration, or physical, chemical or infectious characteristics may cause or significantly contribute and increase mortality or serious illness, or pose a substantial potential hazard to human health. These include paints, thinners, household used batteries, lead-acid batteries, spray canisters, oil, tires and other similar waste materials;

SECTION 3. PENAL CLAUSE: Any person or group of persons violating this Ordinance shall be punished in any of the following, to wit:


1 st Offense	-	fine of not less than	-	PhP	500.00
2 nd Offense	-	fine of not less than	-		1,000.00
3 rd Offense	-	fine of not less than	-		2,500.00

SECTION 4. REPEALING CLAUSE: All previous resolutions and Ordinances or parts thereof which are inconsistent herewith are hereby amended accordingly.

SECTION 5. EFFECTIVITY: This Ordinance shall take effect upon its approval and posting in three (3) conspicuous public places.
