WHEREAS, the Local Government Unit of this municipality had acquired various parcel of land for farm demonstration, and establishment of infrastructure and other developmental projects by way of purchasing and donations;

WHEREAS, said parcel of land needs for subdivision survey to process its Certificate of Title, however the LGU has no registered surveyor, likewise hiring of private surveyor incur expenses;

WHEREAS, fortunately, it was learned that the CENRO had a surveying team which is ready and available at all times to serve to all local government units who officially request its services for subdivision survey hence this resolution.

PREFATORY STATEMENT

In compliance with the provision of the law, memoranda, circulars and other related directives of the NAPOLCOM, the People's Law Enforcement Board (PLEB) of this municipality was organized under Resolution No. 136, s. Of 2004, dated July 15, 2004.

The compositions of the PLEB are as follows:

Local Budget Circular No. 67 authorized for the payment of per diem to the members and support staff of the PLEB and Local Budget Circular No. 73 further clarified existing rules on the grant of compensation benefits to the members.

Both Circulars further fixed the rates of per diem for members in the amount of not exceeding P1,000.00 per session/meeting actually attended but not to exceed P4,000.00 per month, while the secretariat may be provided with P200.00 per session but not to exceed P800.00 per month. The grant thereof is subject to the budgetary limitation on personal services under Section 325 of RA 7160 and availability of funds.

Section 73 of RA 8551 otherwise known as the PNP Reform and Reorganization Act also provides that the Annual Budget of the local government unit shall include an item and corresponding appropriation for the maintenance and operation of their local PLEB

BE IT ORDAINED by the Sangguniang Bayan in session assembled

SECTION I TITLE. This shall be known as "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED THOUSAND (P100,000.00) PESOS FOR THE MAINTENANCE, PER DIEMS AND OTHER EXPENSES IN THE OPERATION OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THIS MUNICIPALITY"

SECTION II. ORDAINING CLAUSE. That the amount of One Hundred Thousand (P100,000.00) Pesos is hereby appropriated to be embodied in the Annual Budget CY 2006 and year thereafter for the maintenance, per diems and other expenses in the operation of the People's Law Enforcement Board (PLEB)

SECTION III. COMPENSATION. As provided herein, and due to limited funds of the Local Government Unit, the People's Law Enforcement Board (PLEB) of this municipality, shall receive honorarium every month based on the following schedule regardless of numbers of sessions:

Chairman	P1,200.00
Members	1,000.00
Secretariat	800.00

SECTION IV. EFFECTIVITY. This Ordinance shall take effect on January 1, 2006 upon approval of the Sangguniang Panlalawigan of Zamboanga del Norte
