PREFATORY STATEMENT

A portion of Rizal Street of this municipality with a distance of 99 meters is traversing the school site of Siayan Central School, hence all types of vehicles using or traveling on this particular street going to barangay Dumpilas, Sitio Suminalum and Municipal Cemetery has to pass the area of the said school.

It had been observed and noted that vehicles like motorcycles, tricycles, jeepneys, and trucks traveling along Rizal Street traversing the Siayan Central School are really endangering the safety and lives of both the pupils and teachers especially during the flag ceremony, recess time, noon break and flag retreat, aside these vehicles also caused disturbance to the on going classes. The safety of all pupils in that school is the concerned of the Teachers and School Principal, however there are instances incidents occur which are beyond the control of the Teachers and Principal because some vehicles are passing the school area very fast and not even blowing its horns, thus accidents happened every school year.

To protect the lives of the pupils and also of the teachers, school Principal and to minimize the disturbance of classes and other school activities, there is a great need to regulate the passage of all types of vehicles at a portion of Rizal Street traversing the Siayan Central School.

BE IT ORDAINED by the Honorable Sangguniang Bayan in Session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE REGULATING THE PASSAGE OF ALL TYPES OF VEHICLES ALONG A PORTION OF RIZAL STREET TRAVERSING SIAYAN CENTRAL SCHOOL".

SECTION II. ORDAINING CLAUSE: That the passage of all types of vehicles at a portion of Rizal Street traversing the Siayan Central School shall be regulated and that no vehicles of all types are allowed to traverse the school area during days with classes on the following time, from 7:00 O'clock in the morning up to 5:00 O'clock in the afternoon. All vehicles intent to go to barangay Dumpilas, Sitio Suminalum or to the Municipal Cemetery shall pass through Sabaricos Street and likewise shall apply the same route to all vehicles coming from Dumpilas, Suminalum and the Municipal Cemetery going to Poblacion Siayan.

Any person or group of persons with vehicles whose purpose is not to traverse but up to the school premises only either to have an appointment or transact official business with the Principal, Teachers, Supervisor or Personnel and/or visited their children are allowed to enter the school site and park their vehicles in a duly designated area.

Such person or group of persons shall observe that the presence of their vehicles in the school area will not endanger the safety of the pupils and also it will not disturb the classes and other school activities therein.


SECTION III. PENALTY CLAUSE. That any violators of this ordinance shall be penalized in the following manner:

1 <sup>st</sup> Offense	- P 500.00
2 <sup>nd</sup> Offense	- 1,000.00
3 <sup>rd</sup> Offense	- 2,000.00 and/or imprisonment of 30 days but not more than 60 days or at the discretion of the honorable court.


SECTION IV. EFFECTIVITY. That this Ordinance shall take effect after 30 days and posting of copies at a conspicuous places and publish in official gazette.


