"APPROPRIATION ORDINANCE NO. 16-17
Series of 2011

PREPATORY STATEMENT

Administrative Order (AO) No. 24 was issued authorizing the grant of Productivity Enhancement Incentive (PEI) to Government Employees for Fiscal Year 2011. Section 8 thereof provides that the grant shall be determined by the Sanggunian depending on the Local Government Unit (LGU) financial capability. Budget Circular No. 2011-4 provides the guidelines on the grant of Productivity Enhancement Incentive (PEI). The Local Finance Committee (LFC) certified the availability of funds.

BE IT ORDAINED by the Sanggunian in session assembled:

SECTION I. TITLE – This Ordinance shall be known as "AN ORDINANCE DETERMINING THE AMOUNT OF PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) FOR PERSONNEL OF THE LOCAL GOVERNMENT UNIT (LGU) OF SIAYAN, ZAMBOANGA DEL NORTE IN THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) FOR FISCAL YEAR 2011."

SECTION II. FUNDING SOURCE – The savings from Personal Services allotments, as certified available by the Local Finance Committee.

SECTION III. COVERAGE – Local Government Unit personnel occupying regular and casual plantilla positions, appointive or elective who are still in the service as of November 30, 2011 and have rendered at least a total or an aggregate of four (4) months of service during the year. Those who have rendered less than the total or aggregate of four (4) months of service as of November 30, 2011 shall be entitled to the pro-rated Productivity Enhancement Incentive as follows:

<u>Length of Service</u>	<u>Percentage of PEI</u>
3 months but less than 4 months	40%
2 months but less than 3 months	30%
1 month but less than 2 months	20%
Less than 1 month	10%

SECTION IV. Payment – The payment shall be made not earlier than December 8, 2011.

SECTION V. Effectivity. – This ordinance shall take effect immediately.
