"APPROPRIATION ORDINANCE NO. 18-05-A Series of 2018

APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF SIXTY SIX MILLION SEVEN HUNDRED TWENTY THOUSAND SIX HUNDRED THIRTY FOUR PESOS AND FIFTY SIX CENTAVOS (PHP 66,720,634.56) INTO UNOBLIGATED BALANCE SOURCE FROM THE CONTINUING APPROPRIATIONS OF THE PREVIOUS YEARS SUBJECT FOR REPROGRAMMING AND BUDGETING FOR CY 2018 FOR VARIOUS EXPENDITURES OF PRIORITY PROJECTS OF THE MUNICIPALITY.

PREFATORY STATEMENT

WHEREAS, the Local Finance Committee certified that the amount of SIXTY SIX MILLION SEVEN HUNDRED TWENTY THOUSAND SIX HUNDRED THIRTY FOUR PESOS AND FIFTY SIX CENTAVOS (PHP 66,720,634.56) is actually available accrued from the previous year continuing appropriations.

WHEREAS, the Municipal Development Council (MDC) had passed Resolution No. 05, Series of 2018, dated July 9, 2018 duly adopted by the Sanggunaing Bayan under SB Resolution No. 159, Series of 2018, dated August 6, 2018 programming the amount (Php 66,720,634.56) for various priority projects.

WHEREAS, as of this present, the projects enumerated therein (MDC Resolution No. 05) remained unimplemented since it is no longer priority hence, this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION 1. TITLE. This Ordinance shall be known as "AN APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF SIXTY SIX MILLION SEVEN HUNDRED THENTY THOUSAND SIX HUNDRED THIRTY FOUR PESOS AND FIFTY SIX TWENTY THOUSAND SIX HUNDRED THIRTY FOUR PESOS AND FIFTY SIX TENTAVOS (PHP 66,720,634.56) INTO UNOBLIGATED BALANCE SOURCE FROM THE CENTAVOS (PHP 66,720,634.56) INTO UNOBLIGATED BALANCE SOURCE FROM THE CONTINUING APPROPRIATIONS OF THE PREVIOUS YEARS SUBJECT FOR CONTINUING APPROPRIATIONS OF THE PREVIOUS PRIORITY REPROGRAMMING AND BUDGETING FOR CY 2018 FOR VARIOUS PRIORITY PROJECTS OF THE MUNICIPALITY.

SECTION II. ORDAINING CLAUSE. That the amount of SIXTY SIX MILLION SEVEN HUNDRED TWENTY THOUSAND SIX HUNDRED THIRTY FOUR PESOS AND Hollance which is free of any encumbrances whatsoever subject for reprogramming and budgeting of various priority projects.

SECTION III. EFFECTIVITY CLAUSE. That this Appropriation Ordinance shall take effect effective upon approval.
