

2. RESOLUTION NO. 27 OF DIONGAN SERIES OF 2005 REQUESTING HONORABLE VICE MAYOR EPHRAIM O. MELINDO AND HONORABLE SB MEMBERS NAMELY: HON. INOCENCIO A. LIMBANG, HON. ESTRELLA S. ZAPATOS, HON. OLIVER B. ATAY, SR., HON. LIBERATO P. NALZARO, HON. JANINA ELISE T. SIASICO AND HON. DAISY A. LIMBANG FUNDING ASSISTANCE IN TERMS OF MATERIALS (50 BAGS PORTLAND CEMENT) FOR THE COMPLETION OF DRAINAGE CANAL OF THE SAID BARANGAY. (Jointly referred with Committee on Public Works) Deferred

Hon. Rudy S. Dominise verified that Resolution No. 27 of Diongan was deferred by his committee on the previous regular session since there was a discrepancy on its request particularly the submission of the Program of Works which was the basis of the amount requested and to be shared among the SB members and the Hon. Vice Mayor. He further stated that it was agreed with Hon. Daisy A. Limbang the Barangay Captain of Diongan to comply the requirements as the pre-requisites in the release of their MIF.

In view that the barangay concerned failed to comply the required pertinent papers, therefore in behalf of the committee, Hon. Rudy S. Dominise moved to return Resolution No. 27 of Diongan with advice to comply the above-mentioned requirements. No objection thus it was carried.

In the portion of the Calendar of Business, two (2) measures were covered under the unfinished business, as follows:

Hon. Felizardo I. Gayapa Sr. justified that Resolution No. 08 and 09 of Balok was deferred by the committee on the previous regular session since the projects mentioned to where the corresponding request for funding chargeable against the identification fund of the Sangguniang Bayan was not listed in the Annual Investment Plan of the barangay therefore it was advice to revise its AIP and incorporate therein the the projects mentioned.

Hon. Gayapa further stated that as he observed, there are some instances that they had approved for the release of their identification fund even the said project where the funds is intended was not listed in Annual Investment Plan of the barangay like Paranglumba on their request for roofing materials of Tulohon School Building. He clarified that maybe there is no harm if they will approve the request of Balok for funding assistance chargeable against the Identification fund of Hon. Samuel G. Baculpo Sr.

Consequently, the latter moved that Resolution No. 08 and No. 09 of Balok be entered in second reading for consideration. No objection thus it was carried.

EXPLANATORY NOTES

The Local Finance Committee of the municipal government of Siayan, Zamboanga del Norte has certified to the probability of collecting the amount of FIFTY ONE MILLION PESOS (P 51,000,000.00) for the year 2006.

Considering on the reports and recommendations of the Committee on Appropriations, ways and means, the Executive Budget submitted for authorization has substantially made operational on the approved Annual Investment Program of the budget year and the 20% Economic Development Plan CY 2006.

The budget has adequately provided funds for the delivery of basic services and the maintenance of facilities as provided for in Sec. 17(b) of RA 7160. Statutory and contractual obligations have been provided. Strict observance of AO 103 is encouraged from the different department heads of adhering to the 25% retention on the

utilization of Maintenance and Other Operating Expenditures appropriations. Procurement of goods and civil works shall strictly follow the provisions of RA 9184 and its implementing rules and regulations.

BE IT ORDAINED therefore by the Sangguniang Bayan in session assembled:

Sec. 1 - **TITLE.** That this ordinance shall be entitled "An Appropriation Ordinance Authorizing the Annual Budget CY 2006 and Making Available the amount of FIFTY ONE MILLION PESOS (P51,000,000.00) for various expenditures of the Local Government Unit of Siayan, Zamboanga del Norte embodied therein."

Sec. 2 - **ORDAINING CLAUSE.** That the Annual Budget CY 2006 is hereby authorized, therefore making available the amount of Fifty One Million (P51,000,000.00) pesos appropriated herein, which funding mix is source from the following:
