"APPROPRIATION ORDINANCE NO. 11-18 Series of 2011

PREPATORY STATEMENT

The Local Finance Committee of the municipal government of Siayan, Zamboanga del Norte had certified to the probability of collecting the amount of EIGHTY EIGHT MILLION SIXTY FIVE THOUSAND TWO HUNDRED SIXTY FOUR PESOS (PhP88,065,264.00) for the year 2012.

Considering the reports and recommendations of the Committee on Appropriations, Ways & Means the Executive Budget submitted for authorization has substantially made operational on the approved Annual Investment Program of the budget year and the 20% Economic Development Plan CY 2012.

The budget has adequately provided funds for the delivery of basiic services and the maintenance of facilities as provided for in Section 17 (b) of RA 7160. Statutory and contractual obligations have been provided. Strict observance of AO 103 is encouraged from the different department heads of adhering to the 25% retention on the utilization of Maintenance and Other Operating Expenditures appropriations. Procurement of goods and civil works shall strictly follow the provisions of RA 9184 and its iimplementing rules and regulations.

BE IT ORDAINED therefore by the Sangguniang Bayan in sessiom assembled:

SECTION I – TITLE: That this Ordinance shall be entitled "AN APPROPRIATION (ORDINANCE AUTHORIZING THE ANNUAL BUDGET FY 2012 AND MAKING AVAILABLE THE AMOUNT OF EIGHTY EIGHT MILLION SIXTY FIVE THOUSAND TWO HUNDRED SIXTY FOUR PESOS (PhP88,065,264.00) FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE EMBODIED THEREIN".

SECTION II – FUNDING ALLOCATION: That the Annual Budget FY 2012 is hereby authorized, therefore making available the amount of EIGHTY EIGHT MILLION SIXTY FIVE THOUSAND TWO HUNDRED SIXTY FOUR PESOS (PhP88,065,264.00) appropriated herein, which funding mix is source from the following:

- (c) That the budget complied with the budgetary requirements and general limitations provided in RA 7160 and its implementing rules and regulations except on personal services limitations, which has been exceeded due to the continued implementation of RA 6758.
- (d) That the execution of this budgetary guidelimes and procedure prescribed in the Budget Operations Manual for LGU's and that the disbursements of authorized expenditures shall be based on the approved work and financial plan and the advice of allotment issued by the Local Chief Exercutive.

SECTION III - USE OF SAVINGS AND AUGMENTATION: In accordance with Section 336 of RA 7160, the Local Government Code of 1991, the Mayor and the Presiding Officer of the Sanggunian are authorized to augment any item in the approved Annual Budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

For this purpose, "savings" refer to portions or balances of any programmed apprropriation free from any obligation or encumbrance still available after the satisfactory completion or the unavoidable discontinuance or abandonment of work, activity or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leavies of absence without pay.

"Augmentation" implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent evaluation of meeded resources,, is determined to be deficient.

SECTION IV - PRIORITY IN THE USE OF PERSONAL SERVICES SAVINGS. Priority shall be given to the personnel benefits of local employees in the use of Personal Services savings.

SECTION V - CHANGES IN THE MUNICIPAL DEVELOPMENT PLAN AND AIIP. In case of changes in the Municipal Development Plan and Annual Investment Plan, resolution and decision of the Executive Committee of MDC is sufficient and executory in order not to delay the impliementation of programs, projects and activities subject of the changes and revisions.

SECTION VI - SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force amd effect.

SECTION VII- EFFECTIVITY: The provisions of this Appropriation Ordinance shall 'take effect on January 1, 2012.
