"APPROPRIATION ORDINANCE NO. 19-01

Series of 2019

**PREFATORY STATEMENT**

The Municipal Treasurer and Municipal Accountant had certified the availability of funds amounting to **TWENTY NINE MILLION NINETY EIGHT THOUSAND FOUR HUNDRED TWENTY THREE PESOS AND SEVENTY ONE CENTAVOS (PHP29,098,423.71)** sourced from Retained Earnings and IRA Difference which is free of any encumbrances available for operation and subject for budgeting to cater the various expenditures of the local government unit of this municipality.

**BE IT ORDAINED** by the Sangguniang Bayan in session assembled:

**SECTION I. TITLE.** This shall be known as " AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF **TWENTY NINE MILLION NINETY EIGHT THOUSAND FOUR HUNDRED TWENTY THREE PESOS AND SEVENTY ONE CENTAVOS (PHP29,098,423.71)** REPRESENTS RETAINED EARNINGS AND IRA DIFFERENCE AVAILABLE FOR OPERATION EMBODIED IN SUPPLEMENTAL BUDGET NO. 1 FY 2019 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

**SECTION II. ORDAINING CLAUSE.** That the amount of **TWENTY NINE MILLION NINETY EIGHT THOUSAND FOUR HUNDRED TWENTY THREE PESOS AND SEVENTY ONE CENTAVOS (PHP29,098,423.71)** is hereby made available for various expenditures of the local government unit. Statement of Funding Sources (LBP Form No. 8) and Statement of Supplemental Appropriation (LBP Form No.9) is hereto attached as form part of this ordinance.

**SECTION III. EFFECTIVITY.** That this ordinance shall take effect upon approval.

**ENACTED** this 11<sup>th</sup> day of March, 2019.
