"APPROPRIATION ORDINANCE NO. 19-05 Series of 2019

APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS (PHP7,860,287.00) INTO UNOBLIGATED BALANCE SOURCED FROM THE CONTINUING APPROPRIATIONS OF THE PREVIOUS YEAR SUBJECT FOR PROGRAMMING AND BUDGETING FOR FY 2019 FOR VARIOUS EXPENDITURES AND PRIORITY PROJECTS OF THE MUNICIPALITY.

PREFATORY STATEMENT

The Local Finance Committee had certified the availability of funds amounting to SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS (PHP7,860,287.00) is actually available accrued from the previous year continuing appropriations.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION 1. TITLE. This shall be known as "REVERTING THE AMOUNT OF SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS (PHP7,860,287.00) INTO UNOBLIGATED BALANCE SOURCED FROM THE CONTINUING APPROPRIATIONS OF THE PREVIOUS YEAR SUBJECT FOR PROGRAMMING AND BUDGETING FOR FY 2019 FOR VARIOUS EXPENDITURES AND PRIORITY PROJECTS OF THE MUNICIPALITY".

SECTION II. ORDAINING CLAUSE. That the amount of SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS (PHP7,860,287.00) is hereby reverted into unobligated balance which is free of any encumbrances whatsoever subject for reprogramming and budgeting of various priority projects.

SECTION III. EFFECTIVITY. That this Appropriation Ordinance shall take effect effective upon approval.
