## **\*APPROPRIATION ORDINANCE NO. 19-06**

## **PREFATORY STATEMENT**

The Municipal Treasurer and Municipal Accountant had certified the availability of funds amounting to SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS (PHP7,860,287.00) sourced from the Reversed Continuing Appropriation which is free of any encumbrances and subject for budgeting to cater the various expenditures of the local government unit of this municipality.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS (PHP7,860,287.00) REPRESENTS THE REVERSED CONTINUING APPROPRIATION EMBODIED IN SUPPLEMENTAL BUDGET NO. 2 FY 2018 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. That the amount of SEVEN MILLION EIGHT HUNDRED SIXTY THOUSAND TWO HUNDRED EIGHTY SEVEN PESOS (PHP7,860,287.00) is hereby made available for various expenditures of the local government unit. Statement of Funding Sources (LBP Form No. 8) and Statement of Supplemental Appropriation (LBP Form No. 9) is hereto attached as form part of this ordinance.

**SECTION III. EFFECTIVITY.** That this ordinance shall take effect upon approval.

**ENACTED** this 1st day of April, 2019.
