**"MUNICIPAL. ORDINANCE NO.19-08

PREFATORY STATEMENT

The Municipal Health Office of the local government unit of this municipality particularly at the Siayan Rural Health Unit Clinical Diagnostic Laboratory provided a Dengue NS1 Screening Test for examination of patients infected of dengue fever, however due to its valuable price in purchasing such screening kit hence the LGU opted to impose fees and charges to sustain its services hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as an **"ORDINANCE IMPOSING FEES AND CHARGES OF DENGUE NS1 SCREENING TEST AT SIAYAN DIAGNOSTIC CENTER, SIAYAN, ZAMBOANGA DEL NORTE**

SECTION II. IMPOSITION OF FEES AND CHARGES: that the amount of SIX HUNDRED PESOS (Php600.00) is hereby imposed for every patient that undergo Dengue Testing.


SECTION III. EFFECTIVITY: That this Ordinance shall take effect upon approval.
