### "MUNICIPAL ORDINANCE NO. 19-11 Series of 2019

#### 261162 01 2013

#### **PREFATORY STATEMENT**

As provided under Section 76, of RA 7160 known as the Local Government Code of 1991, that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

It is in the best interest of the Local Government Unit to create the position of Municipal Agriculturist (MA) that will cater to the necessary programs and project development for the welfare and development of the people in this municipality as far as agriculture is concerned.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE: This Ordinance shall be known as "AN ORDINANCE CREATING THE POSITION OF MUNICIPAL AGRICULTURIST, SALARY GRADE 24/1 OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE AND INCLOSING THE SAME IN THE MUNICIPAL ORGANIZATION CHART AND STAFFING PATTERN AND PLANTILLA OF PERSONNEL AND PROVIDING FUNDS THEREOF.

SECTION II. ORDAINING CLAUSE: That the position of Municipal Agriculturist (MA) is hereby created and inclosing the same in the Municipal Organization Chart and Staffing pattern and Plantilla of Personnel.

**SECTION III. DUTIES AND FUNCTIONS:** The Municipal Agriculturist shall perform its prescribed duties and functions enumerated under Article Twelve, Section 482, paragraph (b) of RA 7160.

**SECTION IV. FUNDING APPROPRIATION:** That the funding appropriation for salaries and other emoluments of the position herein created shall be provided and embodied in the Annual Budget FY 2020.

SECTION V. EFFECTIVITY: This Ordinance shall take effect upon approval.
