**"MUNICIPAL ORDINANCE NO. 19-12  
Series of 2019**

**PREFATORY STATEMENT**

The Local Finance Committee had certified that the amount of FIFTY NINE MILLION SIX HUNDRED TEN THOUSAND ONE HUNDRED TWELVE (PHP59,610,112.03) PESOS AND THREE CENTAVOS is actually available accrued from the previous year which is continuing appropriations.

The programs and projects where the funds had been allocated of the previous year Annual Budget is no longer priority hence it is subject for reprogramming.

**BE IT ORDAINED** by the Sangguniang Bayan in session assembled:

**SECTION I. TITLE.** This Ordinance shall be known as "APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF FIFTY NINE MILLION SIX HUNDRED TEN THOUSAND ONE HUNDRED TWELVE (PHP59,610,112.03) PESOS AND THREE CENTAVOS INTO UNOBLIGATED BALANCE SOURCE FROM CONTINUING APPROPRIATIONS OF THE PREVIOUS YEARS SUBJECT FOR REPROGRAMMING AND BUDGETING FOR CY 2019 FOR VARIOUS EXPENDITURES AND PRIORITY PROJECTS OF THE MUNICIPALITY."

**SECTION II. REVERSION.** that the amount of FIFTY NINE MILLION SIX HUNDRED TEN THOUSAND ONE HUNDRED TWELVE (PHP59,610,112.03) PESOS is hereby reverted into unobligated balance which is free of any encumbrances whatsoever subject for reprogramming and budgeting of various priority projects for CY 2019.

**SECTION III. EFFECTIVITY.** This appropriation ordinance shall take effect upon approval of the Sangguniang Panlalawigan of Zamboanga del Norte.
