**PREFATORY STATEMENT**

The Local Finance Committee had certified the availability of the accumulated funds source from the continuing appropriations of the previous years after having reverted by the Sanggunian Bayan into unobligated balance under Municipal Ordinance No. 19-12, dated September 9, 2019, hence this enactment.

**BE IT ORDAINED** by the Sanggunian Bayan in session assembled:

**SECTION 1. TITLE.** This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF FIFTY NINE MILLION, SIX HUNDRED TEN THOUSAND ONE HUNDRED TWELVE PESOS AND THREE CENTAVOS (PHP59,610,112.03) SOURCED FROM THE UNOBLIGATED BALANCE FY 2019 EMBODIED IN SUPPLEMENTAL BUDGET NO. 3 FY 2019.



**ENACTED** this 16<sup>th</sup> day of September 2019.



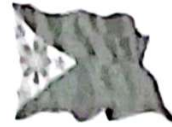


