PREFATORY STATEMENT

Article 231 of the Implementing Rules and Regulations of RA 7160 known as the Local Government Code of 1991 empower the Local Government Unit to levy taxes, fees and charges not otherwise levied by the province.

The Municipal Revenue Code of this municipality was formulated under Ordinance No. 00-002, series of 2000, provided however, in conformance with the provision of Republic Act 7160, Chapter 5, Section 191, adjustment of taxes and other imposition of fees and charges shall be done once in every five (5) years hence this enactment.

BE IT ORDAINED, by the Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

CHAPTER 1 - GENERAL PROVISION

ARTICLE A. TITLE AND SCOPE

SECTION 1. TITLE: This Ordinance shall be known as the "Municipal Revenue Code" of the municipality of Siayan, Zamboanga del Norte, Philippines.

SECTION 2. SCOPE: This code shall govern the levy, assessment, collection of taxes, and other imposition fees and charges within the jurisdiction of the municipality of Siayan, Zamboanga del Norte.

ARTICLE B. DEFINITION AND RULES OF CONSTRUCTION

SECTION 3. DEFINITION OF TERMS:

a) <u>AGRICULTURAL</u> – products include the yield of the soil, such as corn, rice, wheat, rye, coconuts, sugar canes, tobacco, root crops, vegetables, fruits, flowers and their byproducts; Ordinary salt and all kinds of fish, poultry and livestock and animal products whether in their original form or not.

The phrase "whether in their original form or not" refer to the transformation of said products by the farmer, fishermen, producer or owner through the application process to

preserve or otherwise to prepare said products for the market such as: freezing, drying, smoking, or stripping for purposes of preserving or otherwise preparing said products for the market.

- <u>AMUSEMENT</u> is a pleasurable diversion and entertainment. It is synonymous to relaxation, avocation, past time or fun.
- c) <u>AMUSEMENT PLACES</u> includes theaters, cinemas, concert halls, circuses and other places of amusement where one seeks admission to entertain oneself by seeing or viewing the show performances.
- <u>BUSINESS</u> means trade or commercial activity regularly engage as a means of livelihood or with a view to profit.
- e) BANKS AND OTHER FINANCIAL INSTITUTIONS include non-bank financial intermediaries lending investor, finance and investment companies, pawnshop, money shops, insurance companies, stock markets, stock brokers and dealers in securities and foreign hereunder.
- f) BARS includes beer gardens or places wherein intoxicating and fermented liquors or malt are sold, disposed-off, or given away for compensation, even without foods, where the services of hostesses and/or waitresses are employed and where customers are entertained by occasional dancing to music not rendered by regular dance orchestra or musician hired for the purpose, otherwise the place shall be classified as a dance hall or night club, a cocktail lounge is considered a bar even if there are no hostesses or waitresses to entertain customers.
- g) <u>BREWER</u> includes all persons who manufacture fermented liquors of any description or sale or delivery to others, but does not include manufacturers of tuba basic type or similar domestic fermented liquors, whose daily production does not exceed 200 gauge liters.
- BUSINESS AGENT (Agente de negocios) includes all persons who act as agent of others in the transaction of business with any public officer, as well as those who conduct collecting, advertising, employment, or private detective agencies.
- i) <u>CABARET/DANCE HALL</u> include any place or establishment where dancing is permitted to the public in the consideration of any admission, entrance or any other fee paid on, before or after the dancing, and where professional hostesses or dancers are employed.
- j) <u>CARENDERIA</u> refers to any eating place where foods already cooked ready to serve at a price.
- k) <u>COCKPIT</u> includes any place, compound, building or portion hereof, where cockfights are held, whether or not money bet are made on the results of such cockfight.
- COLLECTING AGENCY includes any person, other than a practicing attorney at-law engaged in the business of collecting or suing debts or liabilities placed in his hands, for said collection or suit by subscribers or customers applying and playing therefore, while a "Mercantile Agency" is any person engaged in the business of gathering information as to the financial standing ability, or credit persons engaged in the business and reporting the same subscriber or to customers applying and paying therefore.
- m) <u>COMPOUNDER</u> comprises every person who without rectifying, purifying, or refining distilled spirits, wine or other liquor with any materials except water manufacturer in any intoxicating beverage whatever.
- n) <u>CAPITAL INVESTMENT</u> is a capital which a person employs in any undertakings, or which he contributes to the capital of a partnership, corporation, or any juridical entity or association in a particular taxing jurisdiction.
- CHARGES refers to pecuniary liability as rents or fees against person or property.
- CONTRACTORS includes persons, natural or juridical, not subject to professional tax under Section 311.01 of this code, whose activity consist essentially of the sale of all kinds

of services for fee, regardless of whether or not the performance of the service calls for the exercise or use of the physical or mental faculties of such contractors or his employees.

As used in this section, the term "contractor" shall include general engineering, general building and specialty, contractors as defined under applicable laws; filling demolition and salvage works contractors, proprietors or operators of mine drilling apparatus; proprietors or operators of dockyards; persons engaged in the installation of water system; and gas or electric light, heat or power; proprietors or operator of melting plants; vulcanizing, recapping and battery charging; proprietors or operators of furniture shops and establishments for planning or surfacing and recutting of lumber and sawmills under contract to saw or cut logs belonging to other proprietors or operators or dry cleaning or doing establishments steam laundries, and laundries using washing machines; proprietors or owners shops for the repair of any kind of mechanical and electrical devices, instruments, apparatus, or furniture and shoe repairing by machine or any mechanical contrivance; proprietors or operators of establishments of lots for parking purposes; proprietors or operators of tailor shops; dress shop, milliners and battery, beauty parlors, barbershops, massage clinics, sauna, Turkish and Swedish baths, slandering and building saloons and similar establishments; photographic studios; funeral parlor; proprietors or operators of hotels, motels, and lodging houses; proprietors or operators of arrastre and stevedoring; warehouse of forwarding establishments; masters plumbers; smiths and house or sign painters, bookbinders, lithographers; publishers except those engage in the publication of printing of any newspapers, magazines, review of bulletin which appears at regular intervals which fixed process for subscription and sale and which is not devoted principally to the publication or advertisements; business agents, private detective or watchman agencies, commercial and immigration, brokers and cinematographic film owners, lessors and distributors.

- q) <u>CORPORATION</u> includes partnership, no matter how created or organized, joint stocks companies, joint accounts, (cuentas en participation), associations or insurance companies but does not include general professional partnerships and a joint venture or consortium formed for the purpose of undertaking construction projects or engaging in petroleum coal, geothermal, and other energy operations pursuant to an operating consortium agreement under a service contract with the government. General professional partnerships formed by persons for the sole purpose of exercising their common profession, no part of the income of which derived from engaging in any trade or resident. The term "resident foreign" when applied to a corporation means a foreign corporation not otherwise organized under the laws of the Philippines but engaged in trade or business within the Philippines.
- r) <u>COUNTRYSIDE AND BARANGAY BUSINESS ENTERPRISE</u> refers to a by business entity associations, or cooperative registered under the provisions of Republic Act No. 6810, otherwise known as Magna Carta for countryside and barangay business enterprise (kalakalan 20).
- s) <u>DEALER</u> means one whose business is to buy and sell merchandise, goods, and chattels as a merchant. He stands immediately between the producer or manufacturer and the consumer and depends for his profit not upon the labor he bestowed upon his commodities but upon the skill and foresight with he watches the market.
- t) <u>DISTELLERS OF SPIRITS</u> comprises all who distill spirituous liquors by original continuous distillation from mash, worst, wash, sap or syrup through continuous closed vessels and pipes until the manufacture thereof is complete.
- <u>FEE</u> means as charge fixed by law or ordinance for the regulation or inspection of a business or activity.
- v) <u>FRANCHISE</u> is a right or privilege, affected with public interest which is conferred upon
 private persons or corporations, under such term and conditions as the government and
 its political subdivisions may impose in the interest of public welfare, security and safety.
- w) GROSS SALES OR RECEIPTS include the total amount of money or its equivalent representing the contract price, compensation or service fee, including the amount charged or materials supplied with the service and deposits or advance payments actually or constructively received during the taxable quarter for the services performed or to be

performed for another person excluding discounts of determinable at the time of sales return, excise tax and value added tax (VAT).

- x) <u>HOTELS</u> includes any house or building portion thereof which any person or persons may be regularly harbored or received as transient or guest. A hotel shall be considered as living quarters and shall have privilege to accept any number of guests therein.
- y) <u>IMPORTER</u> means any person who brings articles, goods, wares or merchandise of any kind or class into the Philippines from abroad for unloading therein, or which after such entry are consumed herein or incorporated into the general mass of property in the Philippines. In case of tax free articles, brought or imported into the Philippines by person entities or agencies exempt from tax which are subsequently sold transferred or exchanged in the Philippines to non-exempt private person or entities, the purchaser or recipient shall be considered importer thereof.
- z) <u>INDEPENDENT WHOLESALER</u> means a person other than a manufacturer, producer or importers, who buys commodities for resale to persons other than the end-users regardless of the quantity of the transaction.
- aa) <u>LENDING INVESTOR</u> includes all persons who make a practice of lending money for themselves or others at interest.
- bb) <u>LODGING HOUSE OR BUILDING</u> or portion thereof in which any person or persons maybe regularly harbored or received as transients for compensation, taverns or inns shall be considered as lodging houses.
- cc) MANUFACTURER includes every person who, by physical or chemical process alters the exterior texture or form or inner substance of any raw material or manufactured or partially manufactures product in such manner as to prepare it for special use or uses to which it could not have be put in its original condition, or who by any such process alters the quality of any raw materials or manufactured or partially manufactured products so as to reduce it to marketable shape or prepare it for any of the use of industry, or who by any such process combines any such raw materials or manufactured or partially manufactured products with other materials or products of the same or different kinds and in such manner that the finished product of such process or manufactured can be put to a special used or uses to which such raw materials or manufactured or partially manufactured product in their original condition not have been put, and who in addition alters such raw materials or manufactured or partially manufactured or combined the same to product such finished products for the purpose of their sale or distribution to other and not for his own use of consumption.
- dd) MARGINAL FARMER OR FISHERMAN refers to an individual engaged in subsistence farming or fishing which shall be limited to the sale, barter or exchange of agricultural or marine products produce by himself and his immediate family.
- ee) MONEY SHOP is an extension service unit of a banking institution usually operating in public markets with authority to accept money for deposits and extent short – term loans for specific purposes.
- ff) MOTEL includes any houses or buildings or portion thereof in which any person or persons maybe regularly harbored or received as transients or guest which is provided with a common enclosed garage or individually enclosed garage where such transient or guest may park their motor vehicle.
- gg) MOTORCAB a cab attached a motorcycle usually at the right side or a motorcycle with passenger cab.
- hh) MOTORIZED TRICYLCE a motorcycle fitted with a single wheeled cab operated to render transport services to the general public for fee.
- MOTOR VEHICLE means any vehicle propelled by any power other than muscle power using public roads to exclude road rollers, trolley cars, street-sweepers, sprinklers, lawn mowers, bulldozers, graders, forklifts, amphibian trucks and cranes if not use in public

roads, vehicles which run only on rails or tracks, and tractors, trailers and traction engine of all kinds used exclusively for agricultural purposes.

- jj) MUNICIPAL WATERS includes not only streams, lakes and rivers within the municipality, not being in the subject of private ownership and not comprise with the national park, public forest, timberland, forest reserve or fishery reserve but also marine waters included between two lines drawn perpendicularly to the general coastline from point where the boundary line of the municipality or city touch the sea at low tide and a third line parallel with the general coastline and fifteen (15) kilometers of marine waters between them, then third line shall be equally distant from opposite shores of the respective municipalities.
- kk) <u>OPERATOR</u> includes the owner, manager, administrator, or any other person operates or is responsible for the operation of a business establishments or undertaking.
- II) PAWNBROKERS includes every person engaged in granting loans on deposits or pledges of personal property on the condition of returning the same at stipulated prices, display at his place of business, their gift or yellow bells of exhibiting a sign or money to loan as personal property or deposit pledge.
 - mm) <u>PEDDLER</u> means any person who either for himself or on commission, travels from place to place and sell his goods or offers to sell and deliver the same, whenever a peddler is a whole sale dealer or retail dealer as provided in this title.
 - nn) <u>PEDICAB</u> three-wheeled passenger vehicles which driver propels by peddling and usually with the cab attached to the main cycle at the right side.
 - oo) PERSONS means every natural or juridical being, susceptible or rights and obligations or of being the subject of legal relations.
 - pp) <u>REAL ESTATE DEALER</u> includes any person engage in the business of buying selling, exchanging or renting property as principal and holding himself out as full or part-time dealer in real estate or as aggregate amount of One Thousand (P1,000.00) pesos or more a year; any person shall be considered as engaged in business as real estate dealer by the mere fact that he is the owner or sub-lessor of the property rented or offered to rent for an aggregate amount of One Thousand Pesos or more a year. An owner of sugar lands subject to tax under Commonwealth Act No. 567 shall not be considered as a real estate dollar under this definition.
- qq) <u>RECTIFIER</u> comprises every person who rectifies, purifies or refines distilled spirits of wine; by any process other than by original and continuous distillation from mash, worst, wash, sap, or syrup through continuous closed vessels and pipers until the manufacturer thereof is complete. Every wholesale or retail liquor dealer who has in his possession any still or mush tub or who keeps any other apparatus for the purpose of distilling spirits, or in any manner refining distilled spirits, shall also be regarded as a rectifier and as being engaged in the business of rectifying.
- rr) <u>REPACKER OF WINES OR DISTILLED SPIRITS</u> includes all person who remove wines or distilled spirits from original container for re-packing and selling the same wholesale.
- ss) RESIDENTS refer to the natural person who have their habitual residence in the province, city or municipality where they exercise their civil rights and fulfill their civil obligations, and to juridical persons for which the law or any other provisions creating or recognizing them fixes their residence in a particular province, city or municipality. In the absence of such law, juridical persons are residents of the province, city or municipality where they have their legal residence or principal place of business or where they conduct their principal business or occupation.
- tt) <u>RESTAURANTS</u> refers to any place which provides food to the public and accept orders from them at price. This term included caterers.
- uu) <u>RETAIL</u> means sale where the purchaser buys the commodities for his own consumption, irrespective, of the quantity of the commodities sold.

- vv) TRYCYCLE a three wheeled vehicle worked by pedals and usually with cab in front or at a rear.
- ww) <u>WHOLESALE</u> means a sale where the purchaser buys the commodities for resale, regardless of the quantity of the transaction:

SECTION 4. WORDS AND PHRASES NOT HEREIN EXPRESSLY DEFINED. Words and phrases embodied in this code not herein specifically defined shall have the same definitions as found RA 7160 otherwise known as the Local Government Code of 1991.

SECTION 5. RULES AND CONSTRUCTION: In construing the provisions of this code, the following rules and construction shall be observed unless inconsistent with the manifest intent of the provisions or when applied they would lead to absorbed or highly improbable results.

- a) General Rule All words and phrases be construed and understood according to the Common and approved usage of the language, but technical words and phrases and such other words in this code which may have acquired a peculiar or appropriate meaning shall be construed and understood according to such technical, peculiar or appropriate meaning.
- b) Gender and Number Every word in the code importing the masculine gender shall extend to both male and female. Every word imparting the singular number extent and apply to several persons or things; and every word imparting the plural number shall extend and be applied to one person or thing as well.
- c) Reasonable Time In all cases where any act is required to be done within reasonable time, the same shall be deemed to mean such time as may be necessary for the prompt performance of the act.
- d) Computation of Time The time within which an act is to be done as provided in this code, or any rule or regulation issued pursuant to the provisions thereto. When expressly in days, shall be computed by excluding the first day and including the last day, except if the last falls on Sunday or Holiday, in which case the same shall be excluded in the computation and the day following shall be considered the last day.
- References All references to chapters, articles, or sections are to the Chapters.
 Articles or Sections in this Code unless otherwise specified.
- f) Conflicting Provisions of Chapters If the provisions of different chapter conflict with or contravene each other, the provisions of each chapter shall prevail as to all specific matters and questions involved therein.
- g) Conflicting Provisions of Section If the provisions of the different section in the same article conflict with each other, the provisions of the section, which is the last in point of sequence, shall prevail.

CHAPTER II - MUNICIPAL TAXES AND OTHER IMPOSITIONS

ARTICLE A. BUSINESS TAXES

SECTION 6. IMPOSITION OF TAX: There is hereby levied on the business mentioned in the Article at rates prescribed, therefore the tax is payable for every distinct establishment and one line of business or activity does not become exempt by being conducted with form other business for activity for which a tax has been paid.

- 1. Tax on Business
- a) On manufacturers, assemblers, re-packers, processors, brewers, distillers, rectifiers, and compounds of liquors, distilled spirits, and wines or manufacturers of any article of commerce of whatever kind of nature, in accordance with the following schedule:

6,500,000.00 or more and a rate not exceeding thirty seven and a half percent (37 1/2%) of one percent (1%).

The preceding rates shall apply only the amount of domestic sales of manufactures, assemblers, re-packers, and processors, brewers and distillers, rectifiers and compounds of liquors, distilled spirits and wines or manufacturer of any article of commerce of whatever kind of nature. Export sales are subject to tax rates under paragraph (g) of this Article.

b) On wholesalers, distillers, or retailers of any articles of commerce of whatever kind of nature in accordance with the following schedule:

The above business enumerated in paragraph (a) above shall no longer be subject to the tax on wholesalers, distributors, or dealers here in provided for.

- c) On exporters, and on manufacturers, millers, producers, wholesalers, distributors, dealers or retailers of essential commodities enumerated hereunder at a rate not exceeding onehalf (1/2) of the rates prescribed under sub-section (a), (b) of this section:
 - 1. Rice and corn
 - Wheat of cassava flour, meat, dairy products, locally manufactured, processed or preserved, food, sugar, salt and other agricultural products, marine and fresh water products whether in their original state or not.
 - 3. Cooking oil and cooking gas.
 - 4. Laundry soap, detergents.
 - Agricultural supplements, equal to the post-harvest fertilizers, pesticides, insecticides, herbicides and other farm inputs.
 - 6. Poultry feed and other animal feeds.
 - 7. School supplies, and
 - 8. Cement

For purpose of this provision, the term exporter shall refer to those who are principally engaged in the business of exporting goods or products are both sold domestically and abroad. The amount of export sales shall exclude from the total sales and shall be subject to the rate exceeding one-half (1/2) of the rates prescribed under paragraph (a). (b) and (d) of this article.

d) On retailers:

Barangays shall have the exclusive power to collect taxes on stores whose gross sales or receipt of the preceding calendar year in Thirty Thousand (P30,000.00) pesos or less, subject to existing laws and regulations.

Should a contractor mentioned in this sub-section undertake to furnish the materials and labor for construction work, the cost of such materials and labor shall be deducted from his gross receipts for the purpose of the determining the tax due from him.

In the preceding calendar year, regardless of when the business starts, the tax shall be based on the gross sales and/or receipts for the preceding calendar year or any fraction thereof, as provided in the pertinent schedule.

- f) On banks and other financial institutions such as Non-bank financial intermedianes, lending investors, finance and investment companies, pawnshops, money shops, insurance companies, stock markets, stock brokers and dealers in securities and foreign exchange at rate not exceeding fifty percent (50%) of one percent (1%) on the gross receipts of the preceding calendar year derived from interest, commissions
 - and discounts from lending activities, income from financial leasing, dividends, rentals on property and profit from exchange of sale property, insurance premium.
- g) On peddler engaged in the sale of any merchandise or article of commerce, at a rate fifty pesos (P50.00) annually.
- h) On any business of the rate of two percent (2%) of gross sales or receipts of the preceding calendar year but not less than the amount indicated in the following schedule.

SECTION 7. TIME OF PAYMENT: Unless specifically provided in the article, the tax impose in this article shall accrued on the first day of January of each year as regards subject then liable therefore and the same may be paid in quarterly installments within the first twenty (20) days of January and to its subsequent quarter unless extended by the Sangguniang Bayan for justifiable reason but only for a period not exceeding six (6) months. The tax must be made to the Municipal Treasurer before any business or activity therein specified can be lawfully begin and pursued and the tax shall be reckoned from the beginning of the calendar quarter when the business abandoned, the tax shall not be exacted for a period longer the end of the calendar

quarter. When the tax has been paid for a period longer than the current quarter and the business, trade or activity is abandoned no refund of the tax corresponding to the unexpired quarter or quarters shall be made.

SECTION 8. SURCHARGE FOR LATE PAYMENT: Failure to pay tax prescribed in this article within the time required shall subject the taxpayer to a surcharge of 25% of the original amount of tax due, such surcharge to be paid at the same time and in the same manner as the tax is due.

SECTION 9. INTEREST ON UNPAID TAX: In addition to the surcharge imposed herein, there shall be imposed an interest of 2% per month on the unpaid tax including surcharges the date it is due until it is fully paid but in no case shall the total exceed thirty six (36) months

SECTION 10. ADMINISTRATIVE PROVISIONS:

A) REQUIREMENT – any person who shall established, operate or conduct any business trade or activity mentioned in this article, of this municipality shall first obtained a Mayor's permit and pay the corresponding fees and the business tax imposed under this article.

The tax for a newly started business shall be one – tenth (1/10) of one (1) percent of the capital investment for the first year or one-fourth (1/4) of one (1) percent for the initial quarter.

In the succeeding calendar year, regardless of when the business starts the tax shall be based on the gross sales and/or receipts of the proceeding calendar year or any fraction thereof, or as provided in the pertinent schedule.

B) ISSUANCE AND POSTING OF OFFICIAL RECEIPT – The Municipal Treasurer shall issue an official receipt upon payment of the business tax issuance of the paid receipt shall not relieved the taxpayer from any requirement imposed by the different departments of this municipality.

Every person issued and official receipt for the conduct of business or undertakings shall keep the same conspicuously posted in plain view at the place of business or undertaking. If the individual has not fixed place of business or office, he shall keep the official receipt in his person. The receipt shall be produce upon demand by the Municipal Mayor, Municipal Treasurer or her duly authorized representative.

C) INVOICE OR RECEIPTS – All person subject to the graduated fixed taxes on business, shall for each sale or transfer of merchandise or goods or per services rendered value at five (P5.00) pesos or more at any one time prepare and issue sales on commercial invoices and receipts serially numbered in duplicate showing among others their names or style if any and business sales.

The original of each sales invoices or receipts shall be issued to the purchaser or customers and the duplicate to be kept and preserved by the person subject to said tax in his places of business for a period of five (5) years. The receipts or invoices issued pursuant to the requirement of the Bureau of Internal Revenue for determination of National Internal Revenue taxes shall be sufficient for the purpose of this code.

D) SWORN STATEMENT OF GROSS RECEIPTS OR SALES – Operators of business subject to the graduated fixes taxes shall submit a sworn statement of the capital investment before the start of their business, operations and upon application for a mayor's permit to operate the business upon payment of the tax levied in this article, any person engaged in business subject to the graduated fixed tax based on gross sales and receipts shall submit a sworn statement of his gross sales/ receipts for the preceding calendar year or quarter in such manner in form as may be prescribed by the Municipal Treasurer. If the taxpayer failed to submit a sworn statement of gross sales or receipts or submit fraudulent statement, for whatever reasons including among others that he failed to provide himself with books, records, and/or subsidiaries for his business, the Municipal Treasurer or

his/her duly authorized representative may verify or assist the gross sales or receipts of the taxpayers under this available evidence upon which the tax may be based. In case where a person conducts or operates two (2) or more of the business enumerated in this article which are subject to the same rate of tax, the tax shall be computed on the combined total gross sales or receipts of the said two (2) more related business.

- E) RETIREMENT OF BUSINESS If the business or undertaking is terminated, the official receipt issued for the payment of the business tax therefore shall be surrendered to the Municipal Treasurer and sworn statement of the gross sales and/ or receipts of the current year or quarter shall be submitted to the Municipal Treasurer within thirty (30) days following the closure, if the tax paid during the year be less than the tax due on said year sales or receipts of the current year the difference shall be paid before the Municipal Treasurer issued the corresponding certificate of retirement upon payment of fees required in this code.
- F) ISSUANCE OF CERTIFICATION The Municipal Treasurer may upon presentation satisfactory proof that the original official receipts has been lost, stolen or destroyed, issued a certificate to the effect that the tax has been paid, indicating therein the number of the official receipts issue upon payment of a fee as provided in this code.
- G) TRANSFER OF BUSINESS TO OTHER LOCATION Any business which a municipal tax has been paid by the person connecting, it may be transferred and continue in any other place within the territorial limits of the municipality without the payment of the tax was made.
- H) DEATH OF LICENSE When any individual paying a business tax dies, and the business is continued by a person interested in his state, an additional payment shall be required for the residue of the term for which the tax was paid.

ARTICLE B. COMMUNITY TAX

SECTION 11. IMPOSITION OF TAX:

- A) Every inhabitants of the Philippines particularly within the jurisdiction of Siayan, Province of Zamboanga del Norte, eighteen (18) years of age or over who has been regularly employed on a wage of salary basis for at least thirty (30) consecutive working days during any calendar year who is engage in business or occupation, or who owns a real property with an aggregate assessed value of One Thousand (P1,000.00) pesos or more, or who is required by law to file an income tax return shall pay an annual community tax of five (5.00) pesos and an annual addition tax of one (1.00) peso for every one thousand (1,000.00) of income regardless of whether from business, exercise of profession or from property which is no case shall exceed five thousand (P5,000.00) pesos. In the case of husband and wife residing within the territorial jurisdiction of Siayan, Zamboanga del Norte, the additional tax herein imposed shall be based upon the total property owned by them and the total gross receipts or earning derived by them.
- B) Every corporation no matter how created, organized, whether domestic or resident foreign, engaged in or doing business in the Philippines, within the territorial jurisdiction of Siayan, Zamboanga del Norte shall fee an annual community tax, of Five Hundred (P500.00) pesos and annual additional tax which in no case, shall exceed Ten Thousand (P10,000.00) pesos in accordance with the following schedule:
 - For every Five Thousand (P5,000.00) pesos worth of real property in Siayan, Zamboanga del Norte owned by it during the preceding year based on the valuation or assessed value used for the payment of real property tax under existing laws and the assessment rules of this municipality where the real estate properties are situated an additional of Two (P2.00) pesos, and



 For every Five Thousand (P5,000.00) pesos of gross receipts or earning derived by it from its business in Siayan, Zamboanga del Norte during the preceding year –Two (P2.00) pesos.

The dividends received by a corporation from another corporation however shall, for the purpose of additional tax, be considered as part of the gross receipts of earnings of said corporation.

C) Articles 60 and 61 of the Philippine Cooperative Code of 2008 provide tax exemptions of cooperatives in all its transactions with members, as a recognition that cooperatives are partners of the government in community-building and consequently in nation-building. In pursuant thereto, all Cooperatives accredited/registered within the jurisdiction in the municipality of Siayan are granted a compromise Community Tax in the amount of not more than Php 1,000.00 pesos per year under Ordinance No. 20-01, Series of 2020. A Tax Subsidy is an intentional reduction of the tax burden granted to a certain business or industry to promote consumption or production. It is a benefit awarded by a government as an economic incentive hence this enactment.

SECTION 12. EXEMPTIONS:

The following are exempt from the payment of community tax:

1. Diplomatic and consular representatives; and

Transient visitors when their stay in Siayan, Zamboanga del Norte does not exceed three (3) months.

SECTION 13. TIME AND MANNER OF PAYMENT:

- a) The community tax shall accrue on the first day of January of each year which shall be paid not later than the last day of February of each year. If a person reaches at the age of Eighteen (18) years or otherwise loses the benefits of exemption on or before the last day of June, he/she shall be liable for the community tax on the day he reaches the age of 18 years or loses the benefit of exemption on or before the last day of March, he/she shall have twenty (20) days to pay the community tax without becoming delinquent. Person who come to reside in Siayan, or reach the age of eighteen (18) years or after the first (1st) day of July of any year or who cease to belong to an exempt or on after the same date, shall not be subject to community tax for the year.
- b) Corporation established and organized on or before the last date of June shall be liable for the community tax for that year. Corporation established and organized last day of March shall have twenty (20) days within which to pay the community tax without becoming delinquent. Corporation established and organized on or after the first day of July shall not be subject to the community of tax for that year.

If the tax is not paid within the time prescribed above, there shall be added to the unpaid amount and interest of twenty four (24%) per annum for the due date until it is paid.

SECTION 14. PLACE OF PAYMENT:

- a) The community tax shall be paid to the Municipal Treasurer.
- b) The Municipal Treasurer may be deputized barangay treasurers in this municipality to collect the community tax payable by the individual tax payer and shall be extended only to barangay treasurer who are competent and properly bonded in accordance with applicable laws;
- The additional community tax of any person natural or juridical base on sales or gross receipts of branch, sales office or warehouse located in this municipality shall likewise be paid to the Municipal Treasurer;

- d) No person residing in this municipality shall pay his community tax to other cities or municipalities. Any person, natural or juridical who pays community tax to any other city or municipality shall remain liable to pay such tax to this municipality
- It shall be unlawful for the Municipal Treasurer or their representative to collect or accept payment of community tax from residence of this municipality or juridical person whose principal office is located in this municipality.

SECTION 15. ADMINISTRATIVE PROVISION:

- a) COMMUNITY TAX CERTIFICATE A community tax certificate shall be issued to every person or corporation upon payment of the community tax. A community tax certificate may also be issued to any person or corporation not subject to the community tax (Senior Citizen/PWD, Students) upon payment of one (P1.00) only.
- b) When an individual subject to the community tax acknowledges any document before a notary public, takes the oath of office upon election or appointment to any position in the government service, receives any license, certificate, or permit from any public authority; pays any tax or pay, receives any money from any public fund; transact an official business; or receives any salary or wage from any person or corporation. It shall be the duty of any person, officer, or corporation with whom such transaction is made or business done or from whom any salary or wages is receive to require such individual to exhibit the community tax certificate. The presentation of community tax certificate shall not be required in connection with the registration of voter.
- c) When, through its authorized officers, any corporation subject to the community tax received any license, certificates or permit from any public authority pays any tax or fee, receives money from public funds, or transacts other official business, it shall be the duty of the public official with whom such transactions is made or business done, to require such corporation to exhibit the community tax certificate.
- d) The community tax certificate required in two (2) preceding paragraph shall be the one issued for the current year except for the period from January until the fifteen (15) of April each year in which case, the certificate issued for the preceding year shall suffice.
- e) Acquisition of community tax certificates; distribution of proceeds.
 - The Municipal Treasurer shall source through proper requisition duly approved by the Municipal Mayor, the community tax certificate from the Bureau of Internal Revenue through the Provincial Treasurer in accordance with the prescribed regulations. The treasurer shall see to it that sufficient tax certificates are always available in his custody.
 - 2. The proceeds of tax shall accrue to the General Funds of this municipality and barangay except a portion thereof which shall accrue to the general of the national government to cover the cost of printing and distribution of the forms and other related expenses. The Municipal Treasurer shall remit to the National Treasurer the said share of the national government in the proceeds of the tax within ten (10) days after the end of each quarter.
 - The proceeds of the community tax actually and directly collected by the Municipal Treasurer shall accrue entirely to the general fund of this municipality. However, the proceeds of the

community tax collected through the barangay treasurer shall be a portion as follows;

- 1. Fifty (50%) percent shall accrue to the general fund of this municipality;
- Fifty (50%) percent shall accrue to the barangay where the tax is collected
- f) Every taxpayer paying the community tax shall be required to submit a sworn statement declaring the information required in the preparation and issuance of the community tax certificate to the Municipal Treasurer who shall keep a special file therefore.
- g) The Municipal Treasurer may continue to use the unissued residence certificate BIR Form 9.01, still in his position, until the same are exhausted and/pending receipt of the community tax certificates. For this purpose, he shall superimpose or clearly mark on the face of the certificate the word community tax certificate and the maximum amount on the additional tax payable by individual and corporate taxpayer shall be charge from Three Thousand (P3,000.00) to Five Thousand (P5,000.00) pesos and from Six Thousand (P6,000.00) pesos to Ten Thousand (P10,000.00) pesos respectively.
- h) Violation of any provision of this ordinance or the fraudulent use on the community tax certificate herein provided shall be punishable of a fine of not less than (P1,000.00) pesos nor more than Five Thousand (P5,000.00) pesos or an imprisonment of not less than one (1) month nor more than six (6) months or both at the discretion of the court.
- The Municipal Treasurer shall keep and maintain in his/her office a special file of all sworn statement required under paragraph (a) of this section.

CHAPTER III - PERMITS AND REGULATORY FEES

ARTICLE A. MAYOR'S PERMIT FEES ON BUSINESS

SECTION 16. IMPOSITION OF FEES: There shall be collected an annual fee at the rate of ten (10%) percent of the annual tax due but not less than the rates provided hereunder for the issuance for Mayor's Permit for every business, trade or activity that a person shall conduct within this municipality but in no case shall exceed one thousand (P1,000.00) pesos.

For the purpose of uniformity, the applications for business license and permit shall be accomplished in three (3) copies using the form see Appendix A of this Code.

Upon submission of the application, it shall be the duty of the proper authorities to verify if the other municipal requirements regarding the operations of the business or activity are complied with. The permit to operate shall be issued only upon such compliance and after the payment of the corresponding taxes and fees are required by this revenue code and other municipal ordinances.

The employee of the Office of the Municipal Treasurer who is in-charge of processing the applications shall prepared and accomplished the business license and permit assessment Form

in two (2) copies see (Appendix B) of this code and required the applicant to secure the following before the application shall be processed:

- a) Police Clearance
- b) Fire and Zoning Clearance
- c) Sanitary Permit
- d) Medical Certificate
- e) Realty Tax Clearance
- f) Water Bills and other Obligation Clearance
- g) Rentals and Charges Clearance
- h) Barangay Clearance

Any false statement deliberately made by the applicant shall constitute sufficient ground for denying or revoking the permit issued by the Mayor, and the applicant or license may further be prosecuted in accordance with the penalties provided for in this article.

Mayor's permit shall be refused to any person:

- Whose establishments or undertaking does not conform with zoning regulation and safety, health and other requirements of the municipality.
- That has unsettled tax obligations, debt or other liability to the Municipal government, and
- 3. That the permittee is disqualified under any provisions of law or ordinance to established, or operated the business for which a permit being applied.

SECTION 17. ISSUANCE OF PERMIT: Upon approval of the application of a Mayor's permit, two (2) copies of the application duly signed by the Municipal Mayor shall be returned to the applicant. One copy shall be presented to the Municipal Treasurer as basis for the collection of the Mayor's permit fee and the corresponding business tax.

The Mayor's permit shall be issued by the Municipal Mayor upon presentation of the receipt for the payment of the Mayor's permit fee and the business tax issued by the Municipal Treasurer, and upon compliance of such other forms see Appendices.

Every permit issued by the Mayor shall show the name and residence of the applicant, his nationality and marital status, nature of the organization, that is whether the business is a sole proprietorship, corporation or partnership, etc.; location of business; date of issue and expiration of the permit; and other information as may be necessary.

The Municipal Mayor shall, upon representation of satisfactory proof that the original permit has been loss, stolen or destroyed, issued a duplicate of the permit upon payment of the fees prescribed in this Code.

SECTION 18. POSTING OF PERMIT: Every permit shall keep this permit conspicuously posted at all times his place of business or office or if he has no place of business or office, he shall keep the permit in his person. The permit shall be immediately produced upon demand by the Municipal Mayor, the Municipal Treasurer or anyone of their duly authorized representative.

SECTION 19. DURATION AND RENEWAL OF PERMIT: The Mayor's permit shall be granted for a period of not more than One (1) year and shall expire of the 31st of December following the date of issuance unless revoke or surrendered earlier. It shall have continuing validity only renewal thereof and payment of the corresponding fee.

SECTION 20. REVOCATION OF PERMIT: When a person doing business under the provision of this code violates any provisions of this article refuses to pay an indebtedness or liability to the municipality or abuses his privilege to do business to the injury of the public moral of peace; or when a place where such business is established is being conducted of a disorderly or unlawful manner, is a nuisance, or is permitted to be used as a resort for disorderly characters, criminals or women of ill-repute, the Municipal Mayor may, after investigation, revoke the Mayor's permit and order the closure of the establishment. Such revocation shall operate to forfeit all sums which may have been paid in respect of said privilege, in addition to the fines and imprisonment that may be imposed by the court for violation of any provision of this ordinance governing the

establishment and maintenance of business, and to prohibit the exercise thereof by the person whose privilege is revoke, restored by the Sangguniang Bayan.

SECTION 21. OTHER REQUIREMENTS: The issuance of a Mayor's permit shall not exempt the license from the fulfillment of other requirements in connection with the operation of the business or in the conduct of an activity prescribed under this code or ordinance of the municipality.

SECTION 22. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than P500.00 pesos but not exceeding P1,000.00 pesos or imprisonment of not less than (1) month but not exceeding Six (6) months or both in the discretion of the court, of the permitee.

ARTICLE B. FEES FOR COCKPIT MANAGER, PROMOTERS BET TAKERS, GAFFERS, REFEREES AND MATCH MAKERS

SECTION 23. DEFINITIONS: When used in this article.

- a) COCKPIT MANAGER OR PROMOTER refers to a person who alone or with another initiates a cockfight and/or calls and takes care of bets from owners of both gamecocks and those of other betters before the orders of commencement of the cockfight and thereafter distributes won bets to the winners after deducting a certain commission.
- b) BET MANAGER refuse to an individual who calls and takes care of bets from owner of both gamecocks and those of other betters before he orders commencement of the cockfight and therefore distributes won bets to the winner after deducting a certain commission or both.
- c) GAFFER (Taga-Tari) refers to a person knowledgeable in the art of arming fighting cocks with gaffs on one or both legs.
- d) REFEREE (Sentenciador) refers to a person who watches and oversees the proper gaffing of fighting cocks; determine the physical condition of game cocks while cockfighting is in progress, the injuries sustained by the cocks and their capability to continue cockfighting, and decides and makes known his decision either by work or gesture the result of the cockfight by announcing the winner or deciding a tie in a contest games.

SECTION 24. IMPOSITION OF FEE: There shall be collected and annual Mayor's Permit fee from each cockpit official of cockfighting within the jurisdiction of Siayan, Zamboanga del Norte in the following schedule:

SECTION 25. TIME AND MANNER OF PAYMENT: The Mayor's permit fee shall be paid to the Municipal Treasurer before the gaffer, referee, bet taker or promoter participates in the cockfight. Thereafter, the fee shall be paid annually upon the renewal of the permit on the birth month of the permitee.

SECTION 26. SURCHARGE FOR LATE PAYMENT: Failure to pay the fee prescribed in this article within the time required shall subject the taxpayer to a surcharge of Twenty Five Percent (25%) of the original amount of fee due.

SECTION 27. ADMINISTRATIVE PROVISION: Only license gaffer, referees, bet takers or promoters, cockpit manager and bet manager who officiate in all kinds of cockfights held in the municipality of Siayan. No operator or owner of cockpit shall employ or allow participating in cockfighting any gaffers, referees, bet taker or promoters who has not secured and pay the fee as herein required.

The cockpit operators or owner shall be required by the Municipal Mayor to submit a recommendation of the cockpit officials to be licensed. Only Filipino citizen of good moral character and reputation and have no derogatory police record shall be recommended for licensing.

SECTION 28. PENALTY: Any violation of the provision of this article shall be punished by a fine not less than Two Hundred pesos (P200.00) but not exceeding Five Hundred Pesos (P500.00) or imprisonment of not less than Ten (10) days but not exceeding One (1) month or both of the discretion of court.

SECTION 29. APPLICABILITY CLAUSE: The provision of PD 449 otherwise known as the Cockfighting Law of 1974, shall apply to all matters regarding in the operation of cockpits and the holding of cockfight in the municipality of Siayan, Zamboanga del Norte.

ARTICLE C. LARGE CATTLE REGISTRATION AND TRANSFER FEES

SECTION 30. DEFINITIONS: For purpose of this article "Large Cattle" includes a newly born horse, mule, ass, carabao, cow or other domesticated members of bovine family.

SECTION 31. IMPOSITION OF FEE: The owner of large cattle is required to register his ownership shall be issued to the owner upon payment of a registration fee of P5.00 per head.

If the large cattle be sold or its ownership transferred to another person, the sale or transfer shall likewise be registered with the Municipal Treasurer for which a certificate of transfer shall be issued to the purchaser upon payment of a transfer certificate and pay the amount of P10.00.

SECTION 32. TIME OF PAYMENT: The registration shall be paid to the Municipal Treasurer upon registration or transfer of ownership of large cattle.

SECTION 33. SURCHARGE OF LATE PAYMENT: Failure of the owner to pay the tax prescribed in this article with the same time required shall subject the tax payer to a surcharge of 25% of the original amount of tax due, such surcharge to paid at the same time and the same manner as the tax due.

SECTION 34. ADMINISTRATIVE PROVISIONS:

 Large cattle shall per register with the Municipal Treasurer upon reaching the age of two years.

b) The ownership of large cattle or its sale or transfer of ownership to another person shall be registered with the Municipal Treasurer. All large cattle presented to the Municipal Treasurer shall recorded in a registry book showing the name and residence of the owner; the consideration of purchase price of the animal in cases of sale or transfer, and the class, color, age, sex, brand, and other identifying marks of the large cattle. These shall be stated in the certificate of ownership issued to the owner thereof.

c) If the large cattle is sold or the ownership is transferred to another person the name and residence of the vendor or transferee and the vendees and transferees and all references by number to the original certificate of ownership with the name of the Local Government Unit that issued its shall likewise be indicated in the transfer certificates of transfer shall be issued by the Municipal Treasurer except upon the production of the original certificate of ownership and certificate of transfer and such other documents show title to the owner.

SECTION 35. PENALTY: Any violation of the provision of this article shall be punished by a fine of not less than One Hundred (P100.00) pesos but not exceeding Two Hundred (P200.00) pesos or imprisonment of not less than Ten (10) days but not exceeding One (1) month or both at the discretion of the court.

SECTION 36. APPLICABILITY CLAUSE: All other matters relating to the registration of large cattle shall be governed by the pertinent provisions of the Revised Administrative Code and other applicable laws, Ordinances and rules and regulations.

ARTICLE D. REGISTRATION FEE AND PERMIT FEE TO OPERATE ON BICYCLES, TRICYCLES AND PEDICABS.

SECTION 37. IMPOSITION OF FEE: There shall be collected an annual registration fee and permit fee for every operated and the operation or driving thereof in this municipality

SECTION 38. TIME AND MANNER OF PAYMENT: The fee imposed herein shall be due on the first day of January and payable to the Municipal Treasurer within the first twenty (20) days of January of every year. For bicycles acquired after the first twenty (20) days of January, the permit shall be paid without penalty within the first twenty (20) days following its acquisition.

SECTION 39. SURCHARGE OF LATE PAYMENT: Failure to pay the fee prescribed in this article within the time required shall subject the taxpayer to a surcharge of Twenty Five percent (25%) of the original amount of fee due such surcharge to be paid at the same and in the same manner as the fee due.

SECTION 40. ADMINISTRATIVE PROVISIONS:

- a) A metal plate with corresponding registry number shall be provided by the Municipal Treasurer for every cycle issued a permit upon payment of the cost thereof as determine by the Municipal Treasurer upon acquisition.
- b) The Municipal Treasurer shall keep a registry of all bicycles, tricycles, Pedi cabs and Motor cabs which shall include the following information's:

1.	Make and Brand of bicycle/motorcycle/tricycle
2.	The name and address of the owner; and
3.	The number of metal plate.

SECTION 41. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than One Hundred (P100.00) pesos but not exceeding Two Hundred (P200.00) pesos or imprisonment of not less than Ten (10) days but not exceeding One (1) month, or both, at the discretion of the court.

ARTICLE E. POUNDAGE FEE

SECTION 42. DEFINITION: When used in this article. "ASTRAY ANIMALS" means an animal which is set loose or not under the complete control of the owner, or the one in-charge of the possession thereof, or found in streets, public or private places whether fettered or not. Streets and public places like plaza, school site, municipal site, health center, public market and other government edifice, road sides include provincial, national and barangay roads, parks, plazas and such other places open to the public within the territorial bound of this municipality.

SECTION 43. IMPOSITION FEE: There shall be collected the following poundage fees for each day or fraction thereof from the owner of an astray animal:

Large Cattle P 100.00 All other Domestic Animals 50.00

SECTION 44. TIME AND MANNER OF PAYMENT: The poundage fee shall be paid to the Municipal Treasurer before the animal is release to its owners.

SECTION 45. ADMINISTRATIVE PROVISIONS:

- a) The Chief of Police or PNP /station Commander of this municipality shall apprehend and impound any astray animal which he shall record in a book for this purpose.
- b) The Municipal Treasurer shall cause a notice of the impounding of the animal to be posted at the main door of the municipal hall for five (5) consecutive days, starting one day after the animal is impounded within which the owner is required to claim and established ownership thereof.
- c) If no person shall claim ownership of the animal after expiration of five (5) days from its impounding, it shall be sold at Public Auction under the following procedures:
 - The Municipal Treasurer shall post a notice for five (5) days in two conspicuous
 places including the main door of the Municipal Hall and the public market. The
 animal shall be sold to the highest bidder within five (5) days after the auction
 sale. The Municipal Treasurer shall make a report of the proceeding in writing
 to the Municipal Mayor.

The owner may stop the sale by paying at any time before or during the auction sale. The poundage fee due and the cost of the advertisement and conduct of sale to the Municipal Treasurer, otherwise the sale shall proceed.

- The proceeds of the sale shall be applied to satisfy the cost of impounding, advertisement and conduct of sale. The residue over the cost shall accrue to the General Fund of the municipality.
- In case the impounded animal is not disposed of, within ten (10) days from the date of notice of the public auction, the same shall be considered sold to the municipal government for the amount equivalent to the poundage fees due.

SECTION 46. PENALTY: Owner whose animals caught astray and incurring damages to plants and properties shall pay the following fines:

For the first offense	P	55.00
For the second offense		110.00
For the third offense and each subsequent offense		220.00

In addition to the fine, the owners shall also pay the amount of the damage incurred, if any to the property owner.

ARTICLE F. DOG VACCINATION AND REGISTRATION FEE

SECTION 47. IMPOSITION OF FEE: There shall be collected a vaccination and registration fee of dogs at the rate of Thirty (P35.00) pesos from the owner of a dog at the age of three (3) and older.

SECTION 48. TIME AND PAYMENT: The vaccination and registration fee shall be paid to the Municipal Treasurer upon registration of the dog prior to its vaccination.

SECTION 49. AMINISTRATIVE PROVISIONS:

a) Rabies Vaccination. Every dogs should be submitted by the owner for vaccination against rabies two (2) years or as indicated on the label/literature of

the vaccine. Young dogs shall be vaccinated within thirty (30) days after they have reached three (3) months of age.

- b) During free mass dog rabies vaccination campaign, every dog three (3) months of age and older should be submitted by the owner for vaccination. Dogs not submitted on the scheduled date or within 3 days thereafter shall be kept off or destroyed under provision of the rabies control authority.
- It shall be the duty of each trained vaccination when vaccinating any dog, to complete a certificate of rabies vaccination (in duplicate) for each animal vaccinated. The certificate shall include the following information;
 - 1. Owner's Name, Address and Telephone Number (if any)
 - Description of dog (color, sex, markings, age, name species and breed if any)
 - 3. Dates of vaccination and vaccine expiration (if known)
 - 4. Rabies vaccination tag number
 - 5. Vaccine producer
 - 6. Vaccinator's signature
 - 7. Veterinarians license number/vaccinator's address
- d) Vaccination Cost The cost of rabies vaccines shall be borne by the Local Government Unit, however, the owners shall submit their dogs for registration as provided in this article and pay the corresponding registration fee as determine by the Local Finance Committee.
- e) Elimination of unregistered dogs: unregistered dogs over the age of four (4) months shall be seized and human destroyed under the supervision of a licensed veterinarian or the Municipal Rabies Control Authority base in the absence of registration or vaccination certificate.
- f) Reporting of Biting Incidents The owner of the dog which has bitten any person and the person who has bitten shall within 24 hours of the occurrence report the incident to the Municipal Rabies Control Authority. A health worker or a police receiving such information shall immediately transmit it to the Municipal Rabies Control Authority for investigation.
- g) Liability of Owners Biting Dog The owner of a dog which bitten any person shall be responsible for all treatment and dog examination related expenses incurred by the victims unless the bite was inflicted by a restrained and a registered dog, or had occurred within the owners enclosed premises, in which case arrangement shall be made between the owner and the bite victims.
- h) It shall be the responsibility of the Municipal Rabies Control Authority to administer these provisions and to promulgate the necessary rules and regulation for its implementation. Enforcement shall be the responsibility of the Municipal Rabies Control, defined under this article.

SECTION 50. PENALTY: Any dog owner who fails to abide any of the provisions of this article shall be subjected to a fine of not less than P200.00 but not more than P1, 000.00.

ARTICLE G. PERMIT FEE ON CIRCUS AND PARADE

SECTION 51. IMPOSITION OF FEE: There shall be collected a permit of Fifty pesos (50.00) per day on every circus or menagerie parades or other parade using banners, floats or musical instruments carried in the municipality.

SECTION 52. TIME AND MANNER OF PAYMENT: The fee imposed therein shall be paid to the Municipal Treasurer upon application for a permit to the Municipal Mayor.

SECTION 53. EXEMPTION: Civic, Military parades, religious processions, students parade for any activities, agro-industrial fair shall be exempted from the payment fee imposed herein.

SECTION 54. ADMINISTRATIVE PROVISIONS: Any person that shall held a parade within this municipality shall first obtain a permit from the Municipal Mayor before undertaking the activity. For the purpose, a written application in prescribed form shall set forth the name and

address of the applicant, the place or places where the same will be conducted and such other pertinent information or date as may be required.

SECTION 55. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than Fifty (50.00) pesos but not exceeding One Hundred (P100.00) pesos or imprisonment of not less than Ten Days (10) but not exceeding One (1) month or both at the discretion of the court.

ARTICLE H. PERMIT FEE ON FILM-MAKING AND VIDEOTAPE COVERAGE

SECTION 56. IMPOSITION OF FEE: There shall be collected permit fee of per film from any person that shall go on location filming or have video coverage on any program or activity within the territorial jurisdiction of the municipality in the following schedule

SECTION 57. TIME OF PAYMENT: The fee imposed herein shall be paid to the Municipal Treasurer upon application for the Mayor's Permit before location filming is concerned.

SECTION 58. SURCHARGE FOR LATE PAYMENT: Failure to pay the tax prescribed in this article within the time required shall subject the taxpayer to a surcharge of Two (2) Percent of the original amount of Tax due, such surcharge to be paid at the same time and in the same manner as the tax due.

SECTION 59. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than Five Hundred (P500.00) pesos, or imprisonment of not less than Ten (10) days but not exceeding one (1) month, or both at the discretion of the Court.

SECTION 61. ADMINISTRATIVE PROVISIONS: The application for the construction and/or repair shall be in writing and shall be forth the required information, such as the location and the general dimension of the building and/or other infrastructure of the owner as well as the architecture or engineer who draw the plan, an estimate of the estimated cost of the proposed work and the following:

- a) A copy of a plan showing the location of the building to be constructed with reference to boundaries of the lot and fit constructed in the town proper or Poblacion.
- b) General Drawing:
 - 1. Floor and roof plans
 - 2. Foundation and footing plans
 - 3. Transfer and longitudinal plan
 - 4. Elevation
 - 5. Framing plans showing complete forming of building or structure
 - 6. Isometric flow of plumbing layout
 - 7. Electrical layout and
 - 8. Details of structure and architectural parts.

SECTION 62. PENALTY: Any violation of the provisions of this article—shall be punished by a fine of not more than Four Hundred (P400.00) pesos or an imprisonment of not more than Two (2) months or both at the discretion of the court. Provided that notwithstanding the imposition of fine and imprisonment, the offender shall be required to secure the necessary building permit and pay the corresponding fees thereof or as required by existing ordinance. Provided further, that in case the construction of the building or structure is not in conformity with existing regulations the offender shall be required to remove the said building or structure within a reasonable period upon receipt the order of demolition; and provided finally, that upon failure of the offender to remove or demolish the said building or structure, the Municipal Mayor or his duly authorized representative shall undertake such removal or demolish at the expenses of the offender.

SECTION 63. TIME OF PAYMENT: The fees imposed in this article shall be paid to the Municipal Treasurer upon application of this permit within the office of the Municipal Mayor.

SECTION 65. TIME OF PAYMENT: The fees imposed herein shall be paid to the Municipal Treasurer upon application for his permit with the Municipal Mayor to store the aforementioned substances.

SECTION 66. ADMINISTRATIVE PROVISIONS;

- a) No person shall keep or store at his place of business any of the following flammable, combustible or explosive substances without first securing a permit therefore, gasoline not exceeding the quantity of One Hundred (100) gallons kept in and use by any kind of motor boats. And any quantity of gasoline kept in the tank and used by any motor vehicles shall be exempted from the permit fee herein required.
- b) The Municipal Mayor shall promulgate regulations for the proper storing of said substances and shall designate the proper official and shall have supervisions therefore.

SECTION 67. PENALTY: Violation of this article shall be punished by a fine of Two Hundred (200.00) pesos and imprisonment of two (2) months or both at the discretion of the court.

ARTICLE K. PERMIT FEE FOR HUNTING

SECTION 68. IMPOSITION OF FEE: There shall be collected a fee of Twenty (P20.00) pesos from every person who shall apply for a permit to hunt small or big game within the municipality for a period of not more than Thirty (30) days.

SECTION 69. TIME OF PAYMENT: The hunting permit fee shall be paid to the Municipal Treasurer upon filing of the applicant for the permit from the Mayor thru the Chief of Police.

SECTION 70. ADMINISTRATIVE PROVISION: The hunting permit shall be issued only upon presentation of the applicant of the necessary permit issued by national government office as required by law or regulation for the same purpose.

SECTION 71. PENALTY: Any violation of the provision of this article shall be punished by a fine of not more than Two Hundred (P 200.00) pesos, imprisonment of not more than One (1) month, or both, at the discretion of the court.

SECTION 73. EXEMPTION: Program or activities conducted by education, charitable, religious and government institutions fee to the public shall be exempt from the payment of the fee herein imposed, provided that the corresponding Mayor's permit shall be secured accordingly. Programs or activities requiring admission fees for attendance shall be subject to the fees herein imposed even if they are conducted entities.

SECTION 74. ADMINISTRATIVE PROVISIONS: A copy of every permit issued by the Municipal Mayor shall be furnished to the Chief of Police or Station Commander of the INP Command for the municipality who shall assigned a police to the venue of programs or activities to help maintain peace and order.

SECTION 75. PENALTY: Any violation to this article shall be punished by a fine of not more than One Hundred (P 100.00) pesos or imprisonment of not more than thirty (30) days or both, at the discretion of the court.

SECTION 77. EXEMPTION: Weights and Measures used by government entities or agencies shall be presented to the office of the Municipal Treasurer for proper testing and sealing but shall be exempt from the payment of the fees in this article.

SECTION 78. TIME AND MANNER OF PAYMENT: The fees prescribed in this article shall be paid to the Municipal Treasurer, this municipality upon presentation of the subject scale or measuring device for testing and sealing for the first time and within 20 days from the anniversary of its sealing in case or renewal every year.

Peddlers or itinerant vendors who are residents of this municipality shall likewise pay the fees to the Municipal Treasurer, this municipality.

SECTION 79. SURCHARGE FOR LATE PAYMENT: Failure to the Taxpayer to have this scale or measures presented for testing and scaling annual within the period prescribed in the preceding section shall subject him to a surcharge of 25% of the tax due which shall be collected at the same manner as the tax due.

SECTION 80. ADMINISTRATIVE PROVISIONS:

- Municipal Treasurer are hereby required to keep seals of secondary standard prescribed by the Department of Science and Technology.
- b) Testing and sealing of weights and measures The testing, sealing and licensing of weight and measures shall be the duty of the Municipal Treasurer which should be done before any device of weight and measures shall be use by any person and annual thereafter within 20 days from the anniversaries of its testing, sealing and licensing.
- c) Destruction of defective instruction of weights and measures any defective instrument of weight and measures maybe destroyed by the Municipal Treasurer or his duly authorized representative of its defects is such that it cannot readily and secured be repaired.
- d) Testing of instrument of weights or measures to be use by government agencies shall be tested and sealed free of charge.
- Dealers permits to keep unsealed weights and measures Upon obtaining written permission from the Municipal Treasurer any dealer of weights and measures may keep instrument in stock for sale without sealing until sold or use
 - provided that the Municipal Treasurer or his representative may test the accuracy of the instrument anytime to assure the public that the same are not defective.
- Unlawful possession or use of instrument for months from last sealing Any person making a practice of buying or selling goods by weights of measure, or of furnishing services the value of which is estimated by weights or measure, who has in his possession without permit any unsealed scale, balance, weight and measure, and any person who uses, in any purchased or sale or in estimating the value of any service furnished any instrument of weight or measure that has not been officially sealed, or if previously sealed, the licensed therefore has expired and has not been renewed in due time, shall be punished of not exceeding Five Hundred (P 500.00) pesos or by imprisonment for not exceeding one year or both but if such scale, balance, weight or measure so used has been officially, sealed at some previous time and the seal and tag officially affixed thereto remain intact and in the same position and condition in which they were placed by the official sealer, and instrument is found not to have been altered or rendered inaccurate but still to be sufficiently accurate to warrant its being sealed without repairs or alteration, such instrument shall, if presented for sealing promptly on demand or any authorized sealer or inspector of weights and measures, be sealed, and the owner, possessor or user of same shall be subject to no penalty except, surcharge equal to five times the regular fee fixed by law for sealing of an instrument of its

class, this surcharge to be collected and accounted for by the same official and in the same manner as the regular fees for sealing such instruments.

SECTION 81. PENALTIES AND COMPROMISE: Alteration or fraudulent use of instrument of weight and measure.

- a) Any person who with fraudulent intent alters any scale or balance weight or measure after it is officially sealed, or who knowingly uses any false scale or balance, weight or measure whether sealed or not, shall be punished by a fine of not less than Two Hundred (P 200.00) pesos not more than Two (2) years or both.
- b) Any person who fraudulently given short weight or measure in the making of a sale, or who fraudulently take excessive weight or measure in measurer, fraudulently misrepresent the weight of measure thereof, shall be punished by a fine of not less than Two Hundred (P 200.00) pesos not more than One Thousand (P 11,000.00) pesos or by imprisonment for not less than Three (3) months not more than Six (6) months or both.

SECTION 92. ADMINISTRATIVE PROVISIONS: Marriage license shall not be issued unless a certification issued by the Family Planning Coordinating Council that the applicants have undergone lectures on Family Planning.

SECTION 93. EXEMPTION: The above fees shall not be collected in the following cases.

- a) Issuance of certified copies of documents for official use at the request of a component court or other government agencies.
- b) Issuance of birth certificate of children reaching school age when such certificates are required for admission to the primary grades in public school
- c) Burial permit or a pauper, per recommendation of the Municipal Health Officer and the Mayor.

SECTION 94. PERSONS CHARGED WITH THE DUTY OF NOT REPORTING TO THE LOCAL CIVIL REGISTRAR: The facts of birth, deaths and marriage in accordance with the civil registry law otherwise known as Act. No. 3753, who fails to perform their duties, shall be reported with the Local Civil Registrar this Municipality to the fiscal of the province for proper action and prosecution for violation of the Civil Registry Law.

The following persons are charge with the duty of not reporting the facts of births, deaths and marriage, etc.

For birth: In the following order:

(Rule a2 Adm. Order No. 3 dated 11/04/42 of the Civil Registrar General)

- 1. Physician in attendance of births.
- 2. Midwife/Nurse in attendance at birth.
- 3. Either parents of the newborn child.

For deaths in the following order:

(Rule 25, Adm. Order No. 3 dated 11/04/42 of the Civil Registrar General)

- Physician who attended the deceased.
- 2. Member of the family of the deceased.
- 3. Mayor
- 4. Secretary
- 5. Councilor or SB Member

For marriage:

1. All persons authorize to solemnized marriage in accordance with law.

SECTION 95. PENALTY: Any person violating the provisions of this article shall be punished by a fine of not less than Fifty (P 50.00) pesos or more than One Hundred (P 100.00) pesos and/or imprisonment or not less than ten (10) days or more than Twenty (20) days or both at the discretion of the court.

ARTICLE C. POLICE CLEARANCE FEE

SECTION 96. IMPOSITION OF FEES: There shall be collected a service fee for each police clearance issued as follows:

 a) For domestic & foreign employment, scholarship grant, Study grant

b) For passport or visa application

200.00

c) For local residents for any purpose

100.00

SECTION 97. TIME OF PAYMENT: The service fees imposed in this article shall be paid to the Municipal Treasurer upon application for Mayor's and Police Clearance certificate.

ARTICLE D. MAYOR'S CLEARANCE FEE

SECTION 98. IMPOSITION OF FEES: There shall be collected a service fee for each Mayor's clearance issued as follows:

 a) For domestic & foreign employment, scholarship grant 	ant,

SECTION 99. TIME OF PAYMENT: The service fees imposed in this article shall be paid to the Municipal Treasurer upon application for Mayor's Clearance certificate.

ARTICLE E. SANITARY INSPECTION FEE

SECTION 100. IMPOSITION OF FEES: There shall be collected an annual sanitary inspection fee of Fifty (P 50.00) pesos from each business establishments at this municipality.

SECTION 101. TIME OF PAYMENT: The fee is imposed in this article shall be paid to the Municipal Treasurer after a sanitary inspection of the establishment has been made but prior to the issuance of the sanitary inspection certificate by the Municipal Health Officer and upon renewal of the same every year thereafter within the first Twenty (20) days of January.

SECTION 102. ADMINISTRATIVE PROVISIONS:

- a) The Municipal Health Officer, Sanitary Inspector or his duly authorized Representative shall conduct an annual inspection on all business establishments and buildings to determine the adequacy of ventilation, general sanitary condition and propriety for habitation.
- b) The Municipal Health Officer shall require evidence of payment fee imposed herein before he issue a sanitary inspection certificate.

SECTION 103. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than Fifty (P50.00) pesos but not exceeding One Hundred (P100.00) pesos or imprisonment of not less than Ten (10) days but not exceeding One (!) month or both at the discretion of the court.

ARTICLE F. SERVICE CHARGE FOR GARBAGE COLLECTION

SECTION 104. IMPOSITION OF FEE: There shall be collected from every owner or a business establishment as annual garbage fee in accordance with the following schedule:

SECTION 105. TIME OF PAYMENT: The fees prescribed in this article shall be paid to the Municipal Treasurer in advanced on or before the tenth (10th) day of every month or to the authorized representative who shall collect the said fee from the establishment.

SECTION 106. SURCHARGE FOR LATE PAYMENT: Failure to pay the tax prescribed in this article within the time required shall subject the tax payer to a surcharge of Twenty five (25%) percent of the original amount of tax due, such surcharge to be paid at the same time and in the same manner as the tax due.

SECTION 107. ADMINISTRATIVE PROVISION:

- a) For purposes of the imposition, the area of the garbage collection shall only be the business area of the town proper and public market.
- b) The owner or operator of the aforementioned business establishment shall be provided for his premises the required garbage can or receptacle properly covered which shall be place in front of his establishment before the time of collection of the Municipal Government garbage truck.
- c) The sanitary inspector/or the Municipal Health Officer shall inspect once every month the said business establishment to find out whether garbage is properly disposed within their premises, subject for collection of the garbage truck of the Local Government Unit.

SECTION 108. PENALTY: Any violation of the provision of this article shall be punished by a fine of not less than Two Hundred (P 200.00) pesos, but not exceeding Five Hundred (P500.00) pesos, or imprisonment of not less than Ten (10) days but not exceeding One (1) month, or both, at the discretion of the Court.

ARTICLE G. ASSESSMENT FEES

SECTION 109. IMPOSITION OF FEES: There shall be collected a service fee for services rendered by the Municipal Assessment Office of this municipality.

SECTION 110. ADMINISTRATIVE PROVISION: Fees and charges shall be paid to the Municipal Treasurer's Office, likewise the Municipal Treasurer or his/her duly authorized representative shall issue an official receipt. The Municipal Treasurer shall keep a separate account "Assessment Services" of the collected service fees and/or charges for every issuance of Declaration of Real Property Value whether original or true copy and certification. This ordinance is form part of the Municipal Revenue code of this municipality.

CHAPTER V. MARKET FEES

ARTICLE A. FEES AND CHARGES ON MARKET TIENDAS AND STALLS

SECTION 111. DEFINITION: When used in this article.

Public Market – Refer to the place where building or structure of any kinds, designated by the Sangguniang Bayan as Proper Central Market.

Market Premises – Refers to an open space in the compound part of the market lot consisting of bare grounds, not covered by market building, and usually occupied transient vendors especially during market days.

For purpose of this article, buying and selling of goods in any places except those made by duly licensed establishment within a radius of threes (3) kilometers from the market compound to Proper Central Market, and all other markets established thereafter, are considered made within the market premises and are subject to market fees.

Market Stall – Refers to the subdivision of the market, housing one class group of allied goods, commodities or merchandise.

SECTION 112. MARKET SECTION: For purpose of this article, the public market shall be divided into the following sections.

- a) Fish Section Fresh fish, clams, oysters, lobsters, shrimps, seaweed and other sea foods or marine products.
- b) Meat Section Fresh meat from cow, Carabao, Goat, Sheep, Pig, etc.
- c) Vegetable and Fruit Section All kinds of vegetable, fruit and root crops.
- d) Dry Goods Section All kinds of textiles, ready to wear (RTW) dresses and apparel.
- e) Groceries and Sari-sari Section All kinds of groceries, like biscuits, crackers, all kinds of cakes, butter, cheese, confectioneries, candies, canned goods and other goods, beverages, soft drinks, flour, rice, oatmeal ham, bacon, sugar, nuts, sauce, onions, garlic, potatoes, eggs, toilet articles, corn, sausages, mango, starch, salt, soap, and other household and food products including firewood and charcoal.
- f) Glass wares and farm implements such as harrow, link, rope and the like. All kinds of kitchen utensils made of clay.
- g) Poultry Product Section All chicken, ducks, birds, duckling eggs, poultry foods.
- Eateries and cooked Food Section All kinds of cooked foods including refreshment and cakes
- Miscellaneous Section This includes beauty parlors, tailoring and dress shops, newspapers, and magazine stand, radio and watch repair shops, office supplies and photo studios.

SECTION 113. IMPOSITION OF FEES:

- a) Permanent vendors occupying the old market building owned and/or maintained by the LGU either by stall or tables, shall pay a lot rental at P 22.00 per square meter per month.
- Business Plate shall be established in every establishment and the proprietor shall be charged the corresponding fee in the amount of P 200.00. (subject for changes base on plate and sticker)
- c) Rentals of newly constructed building from the year 2019 and beyond shall be subject for agreement between the lessee and the lessor to be reflected in the lease contract prior occupancy. The rental of stall of the newly constructed building is P3,000.00 pesos per month.
- d) Transient vendors occupying at the open space/lots such as; plaza and parks, sidewalks and road shoulders display their goods/products/items shall pay a rental in the amount of P50.00 per square meter per day and cash tickets depending on the kind and volume of the products displayed.
- e) Market entrance fee for suppliers/distributors/peddlers/ambulant vendors. A market entrance fee shall be collected from transient vendors on the following enumerated commodities:

SECTION 114. ADMINISTRATIVE PROVISIONS:

a) Agricultural products not sold on the day when the corresponding market entrance fee was paid shall be subject to market entrance fee of Twenty Five (25%) percent of the

original imposition. If still displayed or offered for sale the following day and thereafter, the same shall no longer be subject to market entrance fee until sold.

- b) In case the vendor from whom an entrance fee as collected occupies any space with an area in excess of what he paid, for, he shall be required to pay the correct amount of fee due thereon less than what he pay have already paid an entrance fee.
- c) Duly licensed suppliers or distributors of goods, commodities or general merchandise servicing permanent occupants of market stalls, booths, tiendas, or other space, as well as the same occupants when the bring in goods, commodities or merchandise to replenish or augment their stock shall not be considered as transient vendors required to pay the market fees herein authorized.

SECTION 115. TIME AND MANNER OF PAYMENT:

a) FOR STALLS - The fee for the rental of market stalls shall be paid to the Municipal Treasurer or his duly authorized representative with the first Twenty (20) days of each month, in case of a new lease, the lessee shall be required to put a deposit in the amount P 1,000.00 to guarantee payment of rentals and cost of repairs chargeable to the account of the lessee, provided, that any balance thereof shall be returned to the lessee upon termination of the lessee.

SECTION 116. ISSUANCE OF OFFICIAL RECEIPTS AND CASH TICKETS: The Municipal Treasurer or his duly authorized representative shall issue on official receipt as evidence of payment of rentals of fixed stalls.

A cash tickets shall be issued to an occupant of the market premises or transient vendors and his name shall be written on the back thereof. The cash ticket shall pertain only to the person buying the name and shall be good only for the space of the market premises in which he is assigned. If a vendor disposes of his merchandise by wholesale to another vendor, the later shall purchase new tickets if he sells the same merchandise even if such sale is done in the same place occupied by the previous vendor.

SECTION 117. SURCHARGE FOR LATE OR NON-PAYMENT OF FEES:

- a) The lessee of a stall, who fails to pay the monthly rental fee within the prescribed to pay the rental fee for three (3) consecutive months shall cause automatic cancellation of the contract of lease of stall, without prejudice to suing the lessee for the unpaid rents of the expenses of the lessee. The stall shall be declared vacant and subject to adjudication.
- b) Any person occupying space in the market premises without first paying the fee imposed. In this article shall pay three times as such as the regular rate for the space occupied.

SECTION 118. ADJUDICATION OF STALL:

- a) Lease period The contract of lease for a stall shall for a period of one (1) year. renewable upon its expiration, unless revoked in accordance with the provision of this article.
- b) Notice of vacancy A notice of vacancy of newly constructed stalls shall be made for a period of fifteen (15) days immediately preceding the date fixed space is unoccupied and available for lease. Such notice shall be posted conspicuously on the unoccupied stall and the bulletin board of the market. The notice of vacancy shall be written on cardboard of the market, thick paper or any suitable material and shall be in legal form.
- c) Application for Lease (See Appendices)
- The application shall be under oath. It shall be submitted to the Office of the Municipal Treasurer by the applicant either in person or through his/her attorney.
- It shall be the duty of the Municipal Treasurer to keep a register book showing the names and addresses of all applicant for a stall, the number and description of the

stall applied for, and the date and of receipt thereof together with the cash bond or deposit if any.

- 3. The application shall substantially in legal form.
- 4. Applicants who are Filipino Citizens shall have reference in the leases of public stalls. If on the last day set for filing application, there is no application from a Filipino citizen the posting of the Notice of Vacancy prescribed above shall be repeated for another ten (10) days period. If after the expiration of that period there is still no Filipino applicant, the stall affected may be leased to any alien applicant, the adjudication of the stall shall be made thru drawing of lots or public bidding of the rental thereof to be conducted by the Market Committee.
- 5. In case there is only Filipino applicant, the stall applied for shall be adjudicated to him. If there are several Filipino applicants for the same stall, adjudication of the stall be made thru drawing of lots or public bidding of the rental thereof to be conducted by the market committee on the date and hour specified in the notice. The result of the drawing of lots or public bidding shall be reported immediately by the committee to the Municipal Treasurer concerned for appropriation action.
- 6. The successful applicant shall furnish the Municipal Treasurer two (2) Copies of his/her picture immediately after the award of the lease. It shall be the duty of the Treasurer to affix one (1) copy of the picture to the application and the other copy of the record card kept for the purpose.
- 7. Appeals Any application who is not satisfied with the adjudication need by the Municipal Treasurer or the market committee of the stall applied for, may file an appeal with Secretary of Finance through the Municipal Mayor who may submit such appeal with his comment and recommendation as he may desire to make on the matter. The decision of the Secretary of Finance in such cases shall be final.

SECTION 119. MISCELLANEOUS PROVISIONS ON STALLS:

- a) Vacancy of stall before expiration of the lease. If for any reason, a stall holder or lessee discontinue or is required his business before his lease contract expires, such stall shall be considered vacant and its occupancy thereafter shall be disposed of in the manner herein prescribed.
- b) Partnership with stall holder A market stall holder who enters into business partnership with any party after he required the right to lease such stall have no authority to transfer to his partner the right to occupy the stall. In case of death or any legal disability of such stall holder to continue his business, the surviving partner may be authorized to continue occupying the stall for a period not exceeding sixty (60) days within which to wind up the business of the partnership. If the surviving partner is qualified to occupy a stall under the provisions hereof and the spouse, parents, son, daughter or relative within the third degree by consanguinity or affinity of the deceased is not applying to the stall by given the preference to continue occupying the stall concerned, if he or she applies for it.
- c) Lease to personally administer his stall Any person who has been awarded the right to lease a market stall in accordance with the provision hereto, shall occupy, administer and be present personally at his stall or stalls, he may employ helpers who must be citizens of the Philippines, including but not limited to his spouse, parents and children who are actually living with him and are not disqualified under the provision thereto. The person to be employed as helpers shall, under circumstances be persons with whom the stall holder has any commercial relation or transaction.
- d) Dummies: Sub-leased of stall In any case the person registered to be the holder of the lessee of a stall in the public market, is found to be not the person who is actually occupying said stall, the lease of such stall shall be leased his stall to another person or have connived with such person so that the latter may any person, be able to occupy the said stall.

SECTION 120. RESPONSIBILITY FOR MARKET ADMINISTRATOR: The Municipal Treasurer shall exercise direct and immediate supervision and control over the municipal public market and personnel thereof, including those duties concern the maintenance and upkeep of the market premises, in accordance with existing ordinance and other pertinent rules and regulations.

SECTION 121. CREATION OF MARKET COMMITTEE: There is hereby created a permanent market committee composed of the Municipal Treasurer as Chairman, a representative of a Mayor, Sangguniang Bayan, and the market vendors to be appointed by the Municipal Mayor, as members. The Committee will conduct the drawing of lots and opening of bids in connection with the adjudication of vacant or newly constructed stalls in the municipal market and to certify to the Municipal Treasurer of the result thereof.

SECTION 122. RULES AND REGULATIONS:

- a) The peddling or sale outside the public market site or premises of foodstuffs, which easily deteriorate like fish, and meat is hereby prohibited.
- b) No person shall be utilized the public market or any thereof for residential purposes.
- c) It shall be unlawful for any person to peddle, hook, sell or offer for sale, or expose for sale, any article in the passage way (Pasilyo) used by purchasers in the market premises.
- d) It shall be unlawful for any person to resist, obstruct, annoy or impede any market employee or personnel in the performance of his/her duties: nor shall parents allow their children to play in or around their stalls or in the market premises.
- e) No merchandise or article shall be sold, offered for also or exposed for sale in the market unless the same was legally acquired by the vendor or stall holder and that taxes of any kind due thereof has been paid.
- f) It shall be not unlawful for any leases to remove construct or install electrical wiring or water connection nor alter the structure of the stall without prior permit from the market administrator and approved by the Municipal Treasurer.
- g) This municipality shall not responsible to the occupant of the stalls for any loss or damaged caused by fire, theft, robbery, "forcemajeure" on any other cause. All article or merchandise left in the public market during closure time shall be at the risk of the stall holder or owner thereof.
- h) All articles abandoned in the public market building in violation of any provision of this article or any regulations or rule on the management of the market shall be deemed nuisance. It shall be the duty of the Market Administrator or his subordinate to take custody thereof. In case the articles are claimed within twenty four (24) hours thereafter, they shall be returned to their original owner upon payment of actual expenses incurred in their safe-keeping unless they have so deteriorated as to continue a menace to public health, in which case they shall be disposed of in the manner directed by the treasurer, who may also in his discretion cause the criminal prosecution of the guilty party or merely warm him against future violation. In case where the articles have not deteriorated and are not claimed within the time here in fixed, said article shall be sold at public suction in the proceeds thereof shall be disposed in accordance with law.

SECTION 123. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than Five Hundred (P500.00) pesos but not exceeding One Thousand (P1,000.00) pesos or imprisonment of not less than One (1) month but not exceeding six (6) months, or both at the discretion of the court.

ARTICLE B. CHARGES ON MUNICIPAL LOTS OPEN FOR BUSINESSMEN, INVESTORS, CORPORATIONS AND THE LIKE TO CONSTRUCT/ESTABLISH COMMERCIAL BUILDING

SECTION 124. IMPOSITION OF FEE:

- (a) All vacant space identified as commercial lots within the central market premises of Poblacion and including other lots located at the different barangays owned by the local government unit of Siayan, Zamboanga del Norte is open to all businessmen/investors to construct commercial building to operate business.
- (b) Rental of Municipal Lots under lease for construction of Permanent Commercial Structure proposed by any businessmen/investors is P 5.00 per sq. meter per month.
- (c) Pertinent documents shall be secured by any interested parties and pay the corresponding fees prior to enter into "Contract of Lease" as follows:

Application Form
Mayor's Permit
Police Clearance
Zoning Clearance
Fire Clearance
Building Permit

SECTION 125. ADJUDICATION OF LOTS: Occupancy of lots above-described consequently construction of buildings shall be governed with the terms and conditions stipulated in the "Contract of Lease" (Format of Contract of Lease see appendices). Additional terms and conditions not mentioned in the lease contract shall be arranged between the LESSOR and the LESSEE.

SECTION 126. TRANSFER OF THE BUILDING TO THE LGU: The project proponent transfers the facility to the LESSOR (Local Government Unit) at the end of the terms stipulated in the Contract of Lease.

ARTICLE C. SLAUGHTER AND CORRAL FEE

SECTION 127. IMPOSITION OF FEE:

- a) Before any animal is slaughtered for public or home consumption, a permit therefore shall be secured from the Municipal Health Officer concerned or his duly authorized representative who shall determine whether the animal or fowl is fit for human consumption, the Municipal Treasurer shall be issued official receipt upon payment of the corresponding fees.
- b) The fee shall be paid to cover the cost of service in the slaughterhouse of animals at the Municipal slaughter in accordance with following rates.

SECTION 128. PROHIBITION: Permit to slaughter shall not be granted nor the corresponding fees shall not be collected on sick animals condemned by the Municipal Health Officer.

SECTION 129. ADMINISTRATIVE PROVISIONS:

- a) The slaughter of any kind of any animal intended for sale shall be done only in the municipal slaughter designated as such by the Sangguniang Bayan. The slaughter of animals intended for home consumption may be done elsewhere except large cattle which shall be slaughter only in the public slaughterhouse. The animal slaughtered for home consumption shall not be sold or offered for sale.
- b) Before issuing the permit for the slaughter of large cattle the Municipal Treasurer shall be required for branded cattle, the production of the certificate of ownership if the owner is the applicant thereof, or the original certificate of transfer and certificate of ownership showing title in the name of the person applying for the permit if he is not the original owner. If the applicant is not the original owner, and there is no certificate of transfer made in his favor, one such certificate shall be issued and the corresponding fee be collected thereof. For unbranded cattle that have not yet reached the age of branding the Municipal Treasurer shall be required such evidence as well be satisfactory to him regarding the ownership of the animal for which permit to slaughter has been requested. For the unbranded cattle of the required age, the necessary certificate of ownership and or transfer shall be issued and the corresponding fees collected therefore before the slaughter permit is granted.
- c) Before the animal slaughtered for the public consumption, a permit thereafter shall be secured from the representative through the Municipal Treasurer. The permit shall bear the date and month of issued and the stamp of the Municipal Health Officer, as well as the page of the book in which said permit number is entered and wherein the name of permit fee, the kind of any sex of the animal to be slaughtered appears.
- d) The permit to slaughter as herein required shall be kept by the owner to be posted in a conspicuous place in his/her stall at all time.

SECTION 130. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than Five Hundred (P500.00) pesos but not exceeding One Thousand (P1,000.00) pesos or imprisonment of not less than One (1) month but not exceeding (6) months or both, at the discretion of the court.

ARTICLE D. RENTAL AND SALE OF CEMETERY LOT

SECTION 131. IMPOSITION OF FEE:

 For each burial lot consisting of (1x2 meters) Two (2) square meter measurement or Fraction thereof (bare ground)

Collection of the following rental fee for a lease of Five (5) years:

1.1 Ordinary 110.00
1.2 Construction of Niches 330.00
1.3 Apartment Type Niches 1,000.00
After the end of contract term there shall be renewal.

2) Perpetual structures (absolute sale of lot measuring (2 x 3 meters) Six Square meters but not more than two lots per applicant P 2,772.00

SECTION 132. TIME OF PAYMENT: The fee shall be paid to the Municipal Treasurer upon application for a burial permit prior to the construction thereon of any structure whether permanent or temporary, or to the interment of the deceased.

SECTION 133. SURCHARGE FOR LATE PAYMENT: Failure to pay the fee prescribed in this article within the time required shall subject the taxpayer to a surcharge of Twenty five (25%) percent of the original amount of fee, such surcharge to be paid at the same time and in the same manner as the fee due.

SECTION 134. ADMINISTRATIVE PROVISIONS:

- a) Construction of any structure in the public cemetery, whether for temporary or perpetual use, shall only be allowed after the approval of a permit issued by the Municipal Mayor upon presentation of the recommendation of the Municipal Health officer.
- b) Improvement of any structure in the public and private cemetery shall secure building permit at the engineering office.
- c) Renewal of lease. In case of lessee intends to renew the lease after its termination, he must inform the Municipal Treasurer within thirty (30) days before the expiry date of the lease, and shall pay the corresponding rental fees therefore.
- d) It shall be also the duty of the Municipal Treasurer to prepare and submit copies to the Barangay Captains a list of the lease that are to expire five (5) days prior to the expiration date. The Municipal Treasurer shall send a reminder to the lessee of the expiration of his lease, two weeks prior to the expiration date of the lease.
- The Municipal Treasurer shall keep a register on account of the cemetery, together with such additional information as may be required by the Sangguniang Bayan.

ARTICLE E. FEES AND CHARGES ON SPRING DEVELOPMENT WATER SYSTEM (NON-METERED) AND PLUMBING/TAPPING SERVICES OF THE LOCAL GOVERNMENT UNIT

SECTION 139. TIME OF PAYMENT: The water bills due and payable to the office of the Municipal Treasurer within the first five (5) days of the following month of water consumption. Any consumer who fails to pay the monthly payment shall be given a grace period of thirty (30) days after which shall be liable to the surcharge mentioned in the next section.

SECTION 140. SURCHARGE FOR LATE PAYMENT: Failure to pay the fee prescribed in this article within the time required shall subject the consumer to a surcharge of twenty-five (25%) percent of the original amount of fee due, such surcharge to be paid at the same time and in the same manner as the free due.

SECTION 141. ADMINISTRATIVE PROVISION:

- A written application/contract filed with the office if the Municipal Treasurer shall be required for any of the aforementioned services.
- b) A cash deposit of Fifty (P50.00) pesos shall be required for every consumer/applicant before the initial service is rendered, it shall answer for any unpaid due and demandable water rental fees rendered in accordance with the foregoing rates which shall automatically be charged against the cash deposit of the applicant after failure to pay the monthly rental fee within thirty (30) days of the succeeding month. The cash deposit shall be refundable by the Municipal Treasurer if the consumer decided to withdraw the services to the system and all the water bills shall have been fully paid.
- c) For billing purposes, a water meter shall be read one month after its connection and every month thereafter. The meter shall be sealed and the seal shall be broken only when the meter is to be inspected, tested, or adjusted by the system. It shall be tested at any reasonable time by the duly authorized representative/inspector of the system or upon the request of the consumer and to witness by him of he desires to do so. If the testing of the water meter is defective, corresponding adjustments shall be made and none shall be charged to the consumer. If no defect is found in the meter, then the consumer shall pay to the system twenty five (P25.00) pesos for every 5/8" and 3/4" of water and fifty (P50.00) pesos for every water meter bigger than the above.
- d) For re-opening if service upon request of the consumer after it has been closed for delinquency. Fifty (P50.00) pesos shall be charged if the service is closed at the

metering point. If it is closed at the water main or main pipe, the cost of the street repair shall be paid by the consumer.

- e) Service connection for domestic or residential use shall not use pipe bigger than onehalf inch (1/2") in diameter.
- f) Service connection using pipes bigger than one-half (1/2") inch diameter may be allowed for commercial and/or industrial use only, provided that the applicant thereof shall be satisfactorily justify in his application the need of a bigger size which shall in all cases subject to the approval of the Municipal Mayor or Manager.
- g) Every Multi-door apartment shall have separate water service connection and separate water meter for every occupant or lease therein.
- h) In case where the municipal government cannot met the needed supply of water meter, the applicant for a service connection shall furnish himself with a new water meter of a recognized or reputable brand which shall be submitted to and sealed by the Municipal Treasurer or his authorized representative and the installation thereof shall be effective only after the corresponding inspection fee shall have been paid to the Municipal Treasurer.

SECTION 142. PENALTY: Any violations of the provisions of this article shall be punished by a fine of not less than Five Hundred (P 500.00) pesos but not exceeding One Thousand (P1,000.00) pesos, or imprisonment of not less than One (1) month but not exceeding Six (6) months, or both at the discretion of the court.

ARTICLE F. TERMINAL FEE

SECTION 143. IMPOSITION OF FEE: There shall be collected fees for the use of municipal owned parking area(s) in accordance with the following schedule:

SURCHARGE FOR LATE PAYMENT: Failure to pay the fees prescribed in this article within the time required shall subject the taxpayer or the vehicle owner to a surcharge of twenty five (25%) percent of the original amount of the tax due, surcharge to be paid at the same time and in the same manner as to tax fee or due.

SECTION 146. PENALTY: Any violation of the provisions of this article shall be punished by a fine of not less than Five Hundred (P500.00) pesos but not exceeding One Thousand (P1,000.00) pesos or imprisonment of not less than One (1) month but not exceeding Six (6) months or both at the discretion of the court.

SECTION 148. TIME OF PAYMENT: The rentals/fees imposed herein shall be paid to the Municipal Treasurer or her duly authorized representative upon payment of the corresponding rentals and fees.

SECTION 149. ADMINISTRATIVE PROVISION: That any person or private entity that will rent the above-enumerated government properties shall be covered of the following terms and conditions:

- 1. There shall be a lease contract between the parties to be made in the MGSO of the local government unit of Siayan, Z.N. upon payment of the corresponding fees/charges.
- 2. The payment shall be made in advance prior to the use of each property.
- Ordinary wear and tear of the property should be shouldered by the lessor however, extra ordinary damages due to the negligence of the lessee should be shouldered by the lessee.

ARTICLE H. REGISTRATION FEE OF AIRGUNS

SECTION 150. IMPOSITION OF FEE: There shall be collected fees every air guns in the municipality of Siayan in the amount of P50.00 each per annum.

SECTION 151. TIME OF PAYMENT: The fees imposed herein shall be paid to the Municipal Treasurer prior to the registration of air guns in the PNP office of this municipality.

SECTION 152. ADMINISTRATIVE PROVISIONS: All air gun owners is hereby required to register their air guns to the Philippine National Police of Siayan, Zamboanga del Norte to show ownership. The Chief of Police shall keep a record of all air guns in this municipality reflecting therein the name of the owner, residence, number of units, type and serial number of the air gun.

SECTION 153. PENALTY: Any violation of this article and failure to register any air gun with the office of the PNP shall be penalized a fine of P50.00 but not more than P100.00 pesos,

imprisonment of Two (2) days but not more than 3 days and consideration of the air gun or both at the discretion of the court.

TIME OF PAYMENT: The fees imposed herein shall be paid to the Municipal Treasurer or her duly authorized representative and/or to the public toilet care taker upon after he/she urinate, remove bowel and take a bath inside the public toilet. The fees shall be issued a cash ticket for usual accounting and auditing rules and regulations of the government.

SECTION 160. ADMINISTRATIVE PROVISIONS: It shall be unlawful for any person or persons to urinate specifically in the premise of the Municipal Library, Mini-gymnasium, Market Buildings/Stalls or in any other public places or within the vicinity of public market for reason of being unsanitary.

SECTION 161. PENALTY: Any person who violate this article shall be penalized a fine of P50.00 pesos but not more than P 100.00 pesos and imprisonment of five (5) days but not more than 10 days or both fines and imprisonment upon the discretion of the court.

ARTICLE K. REGULATORY FEES FOR BOXING MATCHES

SECTION 162. IMPOSITION OF FEE AND PLACEMENT OF PAYMENT: There shall be collected Mayor's Permit fee in the amount of THREE HUNDRED FIFTY PESOS (P 350.00) per

day/night in every boxing matches and the like in Siayan, Zamboanga del Norte. Mayor's Permit fee shall be paid at the Municipal Treasurer's Office upon issuance of Mayor's Permit.

SECTION 163. ADMINISTRATIVE PROVISION: Any person or group of persons, boxing promoters who conduct boxing matches and the like in Siayan, Zamboanga del Norte shall secure Mayor's Permit prior to the start of the game

SECTION 164. PENALTY: Any violations of this ordinance shall be penalized in the amount of FIVE HUNDRED (P 500.00) PESOS but not more than ONE THOUSAND PESOS (P 1,000.00) or imprisonment of THIRTY DAYS (30) but not more than SIXTY DAYS (60) or both penalty and imprisonment upon the discretion of the Honorable court.

SECTION 173. ADMINISTRATIVE PROVISION: All fees and charges shall be paid to the Municipal treasurer's Office, likewise the Municipal Treasurer or her duly authorized representative shall issue an official receipt collected in a separate account.

ARTICLE P. FEES AND/OR CHARGES OF FARM MACHINERIES (TRACTOR) TD9OD NEW HOLLAND OPERATION/SERVICES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

SECTION 174. IMPOSITION OF FEES: The amount of One Thousand Pesos(P1,000.00) is hereby collected per hectare in the operation/services of farm machinery (Tractor TD90D New Holland Brand) provided however additional fees/charges shall be collected between the travel distance and number of hectares to be cultivated, viz;

> Category A - 0-3 Km travel at least 1 hectare Category B - 3.1 to 10 Km at least 3 Hectare Category C - 10.1 to 18 Km at least 5 Hectare Category D - 18.1 to 25 Km 7 Hectare

Based on the above fractions/indications, there shall be collected additional charges in the amount of P 37.80 per 3 kilometers if the number of hectares does not meet the required categorized travel distance, provided further, that the operation/services of the tractor shall be a minimum of One (1) hectare.

SECTION 175. ADMINISTRATIVE PROVISIONS: The fees and charges herein imposed shall be paid to the Municipal Treasurer's Office and shall likewise issue an official receipt prior to its operation. That the collected fees and charges shall accrue to the General Fund.

ARTICLE Q. REGISTRATION OF CHAINSAW

SECTION 176. IMPOSITION OF FEES: Any person who possessed chainsaw/power saw intended for cutting of trees shall register its chainsaw in the Municipal Environmental and Natural Resources Office and pay the amount of One Thousand Pesos (Php1,000.00).

SECTION 177. ADMINISTRATIVE PROVISIONS: The registration fee herein imposed shall be paid to the Municipal Treasurer's Office and shall likewise issue an official receipt. That the collected fees shall accrue to the General Fund.

ARTICLE R. PERMIT TO CUT

SECTION 178. IMPOSITION OF FEES: Any person or group of person that will harvest its planted trees shall secure Permit to Cut before the Office of the Municipal Mayor and pay the corresponding fees in the amount of Three Hundred (Php300.00) pesos.

SECTION 179. ADMINISTRATIVE PROVISIONS: The fee herein imposed shall be paid to the Municipal Treasurer's Office and shall likewise issue an official receipt. That the collected fees shall accrue to the General Fund.

CHAPTER VI. GENERAL ADMINISTRATION AND PENAL PROVISIONS ARTICLE A. COLLECTION AND ACCOUNTING OF MUNICIPAL REVENUE

73

SECTION 180. COLLECTION: The collection of municipal taxes, fees, charges, surcharges, interest and penalties accruing to this municipality, shall be the responsibilities of the Municipal Treasurer or his deputies in no case shall be delegated to any other person.

Unless otherwise specifically provided in this Code, or under existing laws or decrees the Municipal Treasurer is authorized, subject to the approval of the Municipal Mayor to promulgate rules and regulations for the proper and efficient administration and collection of taxes, fees and charges herein imposed.

SECTION 181. ISSUANCE OF RECEIPTS: It shall be the duty of the Municipal Treasurer or his authorized representative to issue the necessary receipts to the person paying the tax, fee or charges, indicating therein the date, amount, name of the person paying and the amount for which it is paid.

In acknowledging payment of local taxes, fees and charges, it shall be the duty of the Municipal Treasurer or his deputies to indicate on the official receipt issued for the purpose, the number of the corresponding local tax ordinance.

SECTION 182. EXAMINATION OF BOOKS OF ACCOUNTS: For effective enforcing and collection of the taxes, fees and charges provided in this code, the Municipal Treasurer shall secure written authority from the Provincial Treasurer to examine the books of accounts and other pertinent records of any person doing business within the jurisdictional limits of this municipality to verify, assess and collect, the true and correct amount due from the taxpayers concerned. Such examination shall be made during regular business hours not often that one every year for each business establishment. Any examination conducted pursuant to the provisions of this section shall be certified by the official and such certification shall be made of record in the books of accounts of the taxpayer concerned.

SECTION 183. ACCOUNTING COLLECTION: Unless otherwise provided in this code and other existing laws and ordinances all monies collected by virtue of this code shall be accounted for in accordance with the provisions of existing laws, rules and regulations and credited to the General Fund of this municipality.

SECTION 184. ACCRUAL TO THE GENERAL FUND OF FINES, COST AND FORFEITURES: Unless otherwise provided by law or ordinance, fine, costs, forfeiture and other pecuniary liabilities imposed by the Municipal Court for the violation of any Municipal Ordinance shall accrue to the General Fund of the Municipality.

ARTICLE B. CIVIL REMEDIES FOR COLLECTION OF REVENUE

SECTION 185. EXTEND OF MUNICIPAL EQUIPMENT'S LIEN: Taxes and other revenue provided in this code due to this municipality, shall constitute a lien in its favor, enforceable by proper legal action, superior to all liens or charges in favor of private parties, not only upon any property which may be subject to the charge but also upon all properties used in the exercise of the occupation, business or privileges with respect to which the charge is imposed and upon all property rights therein.

SECTION 186. APPLICATION OF CIVIL REMEDIES: Unless otherwise specifically provided in applicable laws and in so far as their nature permits, the remedies provided hereto may be availed of for the collection of delinquent taxes and other imposition provided in this code. The civil remedies available shall be DISTRAINT or personal property and by legal action. Either of these remedies or both simultaneously may be pursued at the discretion of the Municipal Treasurer (Proper authority)

SECTION 187, DISTRAINT OF PERSONAL PROPERTY:

a) Seizure. – Upon failure of the person owning any local tax or other imposition to pay the same at the time record, to the Municipal Treasurer or his deputy may upon written notice, seize or confiscate any personal property belonging to that person to any person property subject to the tax lien in sufficient quantity to satisfy the tax in question, together with any increment thereto incident to delinquency and the expenses of seizure. In this case, the Municipal Treasurer or his deputy shall issue a duly authenticated certificate based upon the records of his office showing the fact of delinquency and the amount of the tax and penalty due. This shall serve as sufficient warrant for the DISTRAINT of personal property aforementioned, subject to the taxpayer's right to claim exemption under the Provision of Section 69 of PD No. 464, otherwise known as the Real Property Tax Code. Distrained personal property shall be sold at the public suction in the manner provided for herein.

- b) Accounting of DISTRAINED Code. The officer executing the DISTRAINED property shall make or cause to be made an account of the goods of effects DISTRAINED, a copy of which shall be signed by himself shall be left either with the owner or person from which possession of goods or effects were taken or at the dwelling or place of business of that person and with someone of suitable age and discretion of which it shall be added a statement of the sum and notice of the time and place of sale.
- c) Publication. Officer executing the DISTRAINT shall forthwith cause a notification to be exhibited in not less than two public places specifying the time and place of sale of the articles DISTRAINED. The time of sale shall not be less than twenty (20) days after notice to the owner or processor of the property as above properties and the publication of posting of the notice. One place for the posting of the notice shall be at the office of the Municipal Mayor.
- d) Release of DISTRAINT upon payment prior to sale if at any time prior to the communication of the sale all proper charges are paid to the officer conducting the sale, the goods or effects DISTRAINED shall be restored to the owner.
- f) Procedure of Sale. At the time and place fixed in the notice, the officer shall sell the goods or effects so distrained at public auction to the highest bidder for cash. Within five (5) days after the sale, the Municipal Treasurer shall be made report of the proceedings in writing to the Municipal Mayor.
- g) Should the property DISTRAINED to be no disposed of within one hundred and twenty (120) days from the day of DISTRAINT, the same shall be considered as sold to the municipality for the amount of assessment made thereon by the Committee on Appraisal and in the extent of the same amount the tax delinquencies shall be cancelled.
- f) Disposition proceeds The proceeds of the sale shall be applied to satisfy the tax, together with the endorsement thereto incident to delinquency and the expenses of the DISTRAINT and sell. Any residue over and above what is required to pay the entire claims shall be returned to the owner of the property sold. The expenses chargeable upon seizure and sale shall embrace only the actual expense of seizure and preservation of the property pending the sale, and no charge shall be imposed for the services of the local officer or his deputy. Where the proceeds of the sale are insufficient to satisfy the claim, other property may, in like manner, be DISTRAINED until the full amount due including all the expenses is collected.

ARTICLE C. - GENERAL PENAL PROVISIONS

SECTION 188. PENALTY: Any violation of the provision of this code not herein otherwise covered by a specific penalty, or of the rules and regulations promulgated under authority. Of this code, shall be punished by a fine of not exceeding One Thousand (P1,000.00) pesos or imprisonment of Six (6) months or both, at the discretion of the Court.

Payment of fine or service of imprisonment as herein provided shall not relived the offender from the payment of the delinquent tax, fee of charges imposed under this code.

If the violation is committed by any juridical entity, the president, General Manager or any person entrusted with the administration thereof at the time of the commission of the violation shall be held responsible or liable.

CHAPTER VII - FINAL PROVISION

SECTION 189. REPEALING CLAUSE: All ordinances, rules and regulations or parts thereof, in conflict with or inconsistent with any provisions of this code are hereby repealed and modified accordingly;

SECTION 190. SEPARABILITY CLAUSE: If, for any reason, any provisions, section or part of this code is declared not valid by a court or competent jurisdiction suspended or revoked by the Secretary of Finance, such judgment does not affect or impair the remaining provisions, sections of part which shall continue to be force and effect;

SECTION 191. APPLICABILITY CLAUSE: All the matters, relating to the provisions in this code shall be governed by the pertinent provisions of existing laws and other ordinance;

SECTION 192. EFFECTIVITY CLAUSE: This Code shall take effect Sixty days (60) after approval of the Honorable Sangguninag Panlalawigan of Zamboanga del Norte and publication of copies in official newspapers.
