PREFATORY STATEMENT

Cleanliness in the community is just as important as cleanliness for individuals and families. Using clean and safe toilets, keeping water sources clean and disposing of human waste safely is a good sanitation. Poor sanitation causes great deal of unnecessary sickness and death.

When human waste (feces) is not managed well, it pollutes water, food and soil with germs and leads to diarrhea and other serious health problems. Using toilets prevents germs from getting into environment and protects the health of the whole community.

Health is not the only reason to build and use toilets. People also wants privacy, safety, comfort cleanliness and respect.

BE IT ORDAINED by the Sangguniang Bayan in Session Assembled:

"MUNICIPAL ORDINANCE NO. 20-07 Series of 2020

SECTION I. TITLE. This shall be known as "AN ORDINANCE PENALIZING ANY HOUSEHOLDS WITH NO WATER SEALED TOILET IN SIAYAN, ZAMBOANGA DEL NORTE.

SECTION II. DEFINITION OF TERMS. As used in this Ordinance, the following terms are hereby defined:

- 1. WATER SEALED TOILET fixture for disposing of body waste and sealed by water that prevent escape of unpleasant smells.
- 2. SANITATION Public cleanliness, health and hygiene
- 3. HOUSEHOLD a people who live together in a single home.
- 4. CLEANLINESS A degree to which somebody clean.

SECTION III. BASIC PROVISIONS:

- a) It is mandatory that every household shall have a functional water sealed toilet.
- b) Every water sealed toilets establish outside the residential building should be provided with roofs and walls.
- c) Every water sealed toilets should be provided with water reservoir or plastic container or water tub and dipper.

d) Every water sealed tollets shall be properly cleaned and ready for inspection anytime.

SECTION IV. ADMINISTRATIVE PROVISION. The Local Government Unit through the Rural Health Unit (RHU) or its authorized representative, Sanitary Inspector and Barangay Officials concerned shall conduct routinary inspection on the Water sealed toilets of every household in the different barangays of Siayan, Zamboanga del Norte.

SECTION V. PENALTY CLAUSE. Every household failed to construct water sealed toilet, likewise constructed water sealed toilet but not using it is a violation of this ordinance and shall be penalized in the following manner:

- 1th offense (first Inspection)...... 500.00 pesos
- 2nd offense (2nd Inspection) 1,000.00 pesos
- 3rd Offense (3rd Inspection) 2,000.00 pesos
- 4th Offense (4th Inspection) imprisonment of 30 days but not more than
 60 days or both fines and imprisonment at the discretion of the Honorable Court.

SECTION VI. REPEALING CLAUSE. The provision of the previous ordinances or other local issuances inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION VII. SEPARABILITY CLAUSE. If for any reason, any part or provision of this Ordinance shall be declared unconstitutional or invalid, such parts or provisions not affected thereby shall remain in full force and effect.

SECTION VIII. EFFECTIVITY. This Ordinance shall take effect 30 days after approval of the Sangguniang Panlalawigan of Zamboanga del Norte and publication in the official gazette of local circulation.
