The Local Finance Committee had certified the availability of the accumulated funds source from the retained earnings of the previous FY 2019 which is available for operation.

BE IT ODAINED by the Sangguniang Bayan in session assembled:

"MUNICIPAL ORDINANCE NO. 20-12

Series of 2020

SECTION 1. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF EIGHTEEN MILLION TWO HUNDRED THIRTYSIX THOUSAND SIX HUNDRED TWENTYEIGHT PESOS AND FORTYTWO CENTAVOS (PHP18,236,628.42) SOURCED FROM RETAINED EARNINGS OF THE PREVIOUS FY 2019 EMBODIED IN SUPPLEMENTAL BUDGET NO. 1 FY 2020.

SECTION II. AVAILABILITY OF FUNDS. That the amount of EIGHTEEN MILLION TWO HUNDRED THIRTYSIX THOUSAND SIX HUNDRED TWENTYEIGHT PESOS AND FORTYTWO CENTAVOS (PHP18,236,628.42) is hereby made available for various expenditures of the LGU. Pertinent documents are hereto attached as form part of this ordinance.

SECTION III. EFFECTIVITY. This Ordinance shall take effect upon approval.
