PREFATORY STATEMENT

Republic Act 9514, known as Comprehensive Fire Code of the Philippines 2008 provides that flammable and combustible liquid shall be stored on approved containers or tanks properly labelled with the physical properties of its content, flammability or combustibility and precautionary measures. RA 9514 is often all not that comprehensive when it comes to regulating the bote-bote de gasoline (tingi-tingi).

The continued operation of unsafe and sub-standard retail outlets (e.g. bote-bote/tingitingi) may expose the consuming public to fire, security, health and environmental risk and it deprive the municipal government of revenue derived from licensing fees, local business taxes and pump calibration charges and encourage smuggling pilferage and theft of liquid petroleum products.

Batas Pambansa Blg. 33 as amended by Presidential Decree No. 1865 and the implementing rules and regulations therefore, defines and penalizes prohibited acts including ille4gal trading in the petroleum products, adulteration and under-delivery among others.

Municipal Ordinance No. 92-05, Series of 1992 the same was prohibiting the sales of gasoline, however such regulation was specifically in the public market of barangay Poblacion operated by the local government of this municipality.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

"MUNICIPAL ORDINANCE NO. 20-18

Series of 2020

SECTION I. TITLE. This Ordinance shall be known as "AN ORDINANCE PROHIBITING THE SELLING/RETAILING OF GASOLINE AND DIESEL FUEL OIL (TINGI-TINGI) IN ALL SARISARI STORES, AND/OR STORES ESTABLISHED IN THE RESIDENTIAL BUILDINGS, PUBLIC MARKET WITHIN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE AMENDING MUNICIPAL ORDINANCE NO. 92-05, SERIES OF 1992.

\$ECTION II. DEFINITION OF TERM\$: For purposes of this Ordinance, the following terms shall mean:

• Flammable /Combustible liquid – refers to liquids that can easily caught by fire. (Ex. Gasoline, petroleum gas, etc)

- Bottled Soda refers to the bottled glass used in retailing gasoline/diesel oil.
- Sari-Sari Store a place where selling/retailing of different goods established in a separate area and/or established attached in the residential house.

SECTION III. PROHIBITED ACTS. Selling and/or retailing of gasoline/diesel in sarisari stores, residential buildings or in other unauthorized places are hereby strictly prohibited.

SECTION IV. PENAL PROVISION. Any person or group of persons that violates the provisions of this ordinance shall be penalized in the following manner:

First Offense 500.00

Second Offense 1,000.00

and imprisonment of 30 days but not more than 60 days.

SECTION VI. EFFECTIVITY. This Ordinance shall take effect upon approval.
