PREFATORY STATEMENT

Section 76 of Republic Act No. 7160 states that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

The local officials as part of its management and concerned desire to motivate employees by way of promotions to a higher salary grade particularly to those deserving and qualified employees. Nevertheless, some positions of the respective offices which are no longer necessary are opted to be dissolved and various positions shall be created which are very indispensable in the operation of local governance.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

"MUNICIPAL ORDINANCE NO. 20-20

Series of 2020

SECTION I. TITLE: This Ordinance shall be known as **"AN ORDINANCE DISSOLVING CERTAIN POSITIONS AND THE SAME TIME CREATING VARIOUS POSITIONS IN THE RESPECTIVE OFFICES AND THE NEW CREATED POSITIONS SHALL BE INCORPORATED IN THE PLANTILLA OF PERSONNEL AND STAFFING PATTERN OF THE LOCAL GOVERNMENT UNIT OF SLAYAN, ZAMBOANGA DEL NORTE."**

SECTION II. DISSOLVED POSITIONS: That the following positions are hereby dissolved:

SECTION IV. FUNDING APPROPRIATION: That the funds for salaries and other emoluments of the position herein created shall be provided to be incorporated in the Annual Budget FY 2021.

SECTION V. EFFECTIVITY: This Ordinance shall take effect upon approval in conformance with the government accounting and auditing rules and procedures.


