## "APPROPRIATION ORDINANCE NO. 13-21 Series of 2013


#### PREFATORY STATEMENT

The municipality of Siayan is a recipient of livestock production under the Bottoms Up Budgeting (BUB) Program of the Department of Agriculture (DA) however, such implementation is under contract wherein the Local Government Unit concerned has a counterpart part fund hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE FOR COUNTERPART FUND IN THE IMPLEMENTATION OF LIVESTOCK PRODUCTION CHARGEABLE AGAINST THE 20% EDF UNDER ACCOUNT CODE NO. 8711-20%-300-260".
