PREFATORY STATEMENT

WHEREAS, under Section 6, Article 99 of the Local Government Code sates "the Sangguniang Bayan shall protect the environment and impose appropriate penalties for acts which endanger the environment such as activities which result in pollution, destruction of rivers and lakes, or of ecological imbalance";

WHEREAS, as provided of the same code (Republic Act 7160) the municipalities may impose and collect such reasonable fees and charges on businesses and occupations;

WHEREAS, there is a need for the Municipal Government of Siayan to enact an enabling ordinance to address the aforementioned concerns, and for the effective implementation in the preservation of the ecological balance of the environment and its sustainable development as well as preventing and abating pollution due to industrial, commercial, and agricultural establishments and among other either government and private entities;

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

**"MUNICIPAL ORDINANCE NO. 23-09
Series of 2023**

AN ORDINANCE PRESCRIBING THE ENVIRONMENTAL INSPECTION FEES TO ALL INDUSTRIAL, COMMERCIAL AND AGRICULTURAL ESTABLISHMENTS AND PRIVATE ENTITIES WHOSE ACTIVITIES ARE POTENTIAL SOURCES OF LAND, AIR AND WATER POLLUTION AND FOR OTHER PURPOSES.

SECTION 1. TITLE. This Ordinance shall be known and cited as the "**ORDINANCE PRESCRIBING THE ENVIRONMENTAL INSPECTION FEES TO ALL INDUSTRIAL, COMMERCIAL AND AGRICULTURAL ESTABLISHMENTS AND PRIVATE ENTITIES WHOSE ACTIVITIES ARE POTENTIAL SOURCES OF LAND, AIR AND WATER POLLUTION AND PENALIZING ANY VIOLATION THEREOF.**"

SECTION 2. DECLARATION OF POLICY. To promote environmental protection and to help accelerate development, it is hereby declared as a policy of the Municipal Government of Siayan to impose Environmental Inspection Fee to all industrial, commercial and agricultural establishments and private entities whose activities are potential sources of land, air and water pollution and for other purposes."

SECTION 3. ADMINISTRATIVE PROVISION: The municipal government of Siayan through the Municipal Environmental and Natural Resources Office (MENRO) shall conduct supervision and enforce the rules and regulations for the protection of the environment to all industrial, commercial and agricultural establishments and private entities. Environmental Permit to operate shall be issued upon payment the corresponding fees.

SECTION 4. ENVIRONMENTAL INSPECTION FEE: Every owner/operator of business, industrial, commercial and agricultural establishments, shall be charged on Environmental Inspection Fee for inspection and compliance monitoring, namely:

1. ALL HIGH-RISK INDUSTRIES AND ESTABLISHMENTS;

• Fuel depot and fuel storage facilities	P2,500.00
• Gasoline service and LPG filling stations	1,500.00
• All big scale manufacturing industries	1,500.00
• Private hospitals	1,000.00
• Markets/shopping centers	1,000.00
• Cell site substations	1,000.00
• Junkshops	500.00
• Retailer of LPG tanks	500.00

2. ALL INDUSTRIES/ESTABLISHMENTS WITH POTENTIAL SOURCE OF POLLUTION (WATER, AIR, NOISE)

• Small-scale manufacturing industries	800.00
• Housing development projects	1,000.00
• Fast food chains/restaurants	1,000.00
• Terminal/Garage of transport trucking services	1,000.00
• Medical clinics	1,000.00
• Hotels, motels, lodging house, Inns	1,000.00
• Welding shop	700.00
• Auto repair with repainting shop	700.00
• Refrigerator repair with repainting shop	500.00
• Furniture shop	500.00
• Car wash, laundry services	500.00
• Funeral services	500.00
• Animal farm/piggery/poultry	500.00
• Warehouses	500.00
• KTV Bar	

SECTION 5. PENALTIES: Any violation of this Ordinance shall be penalized in the following manner:

1. Failure to secure Environmental Permit to Operate - P2,000.00
2. Refusal on the entry of MENRO Inspectorate - 2,000.00

SECTION 6. SEPARABILITY CLAUSE. If any section, phrase, sentence or portion of this ordinance is held invalid or unconstitutional for any reason by any court of competent jurisdiction, such portion shall be deemed separate, distinct and independent provision, and such shall not affect the validity of the remaining portions thereof.

SECTION 7. REPEALING CLAUSE. All Ordinance and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 8. EFFECTIVITY. This ordinance shall take effect after its approval by the Hon. Sangguniang Panlalawigan in the Province of Zamboanga del Norte and publication according to law.
