**PREFATORY STATEMENT**

Whereas, the municipality of Siayan, Zamboanga del Norte is a recipient of Level II Potable Water System (Level II PSW) project from the Department of Agriculture (DA) under the Philippine Rural Development Program (PRDP) particularly Construction of Domogok-Paranglumba-Balok-Poblacion, Level II Potable Water System.

Whereas, such assistance is under contract wherein the recipient Local Government Unit is required to provide a counterpart fund for its implementation, hence this enactment.

**"APPROPRIATION ORDINANCE NO. 23-10**

**SECTION I. TITLE.** This shall be known as **"AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF FOUR MILLION EIGHT HUNDRED NINETY THREE THOUSAND EIGHTY FIVE PESOS AND FIFTY CENTAVOS (PHP4,893,085.50) SOURCED FROM THE 20% EDF AS COUNTERPART FOR THE PRDP PROJECT - CONSTRUCTION OF DOMOGOK-PARANGLUMBA-BALOK-POBLACION LEVEL II POTABLE WATER SYSTEM.**

**SECTION II. AVAILABILITY OF FUNDS.** That the amount of FOUR MILLION EIGHT HUNDRED NINETY THREE THOUSAND EIGHTY FIVE PESOS AND FIFTY CENTAVOS (PHP4,893,085.50) SOURCED FROM THE 20% EDF CY 2023 is hereby made available.

**SECTION III. EFFECTIVITY.** That this ordinance shall take effect upon approval.
