PREFATORY STATEMENT

The Philippine Statistics Office (PSA) issued a Memorandum Circular No. 2022-01 subject of such is "Dessimination of the Revised Guidelines for Delayed Registration of Birth" as provided under DILG-PSA Joint Memorandum Circular No, 2021-01.

One of the guidelines provided therein under paragraph 9.0 is the collection of fees for the delayed Registration of Live Birth, hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

**"MUNICIPAL ORDINANCE NO. 24-05
 Series of 2024**

SECTION I. TITLE: This shall be known as an **"ORDINANCE IMPOSING FEES AND CHARGES ON DELAYED REGISTRATION OF LIVE BIRTH** in Siayan, Zamboanga del Norte."

SECTION II. IMPOSITION OF FEES AND CHARGES: That the amount of TWO HUNDRED PESOS (Php200.00) is hereby imposed for every application of delayed live birth in the Local Registrar's Office (LCR).

SECTION III. EFFECTIVITY: That this Ordinance shall take effect upon approval.
