"MUNICIPAL ORDINANCE NO. 24-12 Series of 2024

AN ORDINANCE AUTHORIZING THE UTILIZATION AND ALLOCATION PERCENTAGE AND SHARING SCHEME OF PHILHEALTH INSURANCE CORPORATION (PHIC) ON REIMBURSEMENT CLAIMS OF RURAL HEALTH UNIT (RHU) OF LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

INTRODUCED BY: HON. DAISY A. LIMBANG

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in a session duly assembled that:

SECTION I. TITLE. This Ordinance shall be known as the "PHILHEALTH CLAIM ORDINANCE OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

SECTION II. SCOPE. This Ordinance covers reimbursement claims received from PHIC of the Rural Health Unit of LGU - Siayan.

SECTION III. LEGAL BASIS. This Ordinance is enacted in pursuant to the following:

- a. PhilHealth Insurance Corporation Circular No. 2017-0020, subject: Implementation of Auto-Credit Payment Scheme (ACPCs) to all Health Care Institutions; and
- b. PhilHealth Circular No. 014-2014, subject: Revised Guidelines for the Philhealth Outpatient Anti-Tuberculosis Directly observed Treatment Short-Course (DOTS) Benefit Package.

SECTION IV. UTILIZATION AND ALLOCATION PERCENTAGE OR SHARING SCHEME FOR FACILITY OPERATIONAL FUNDS, PROFESSIONAL FEES AND RHU STATIONED PERSONNEL. The following utilization and allocation percentage or sharing scheme from PHIC are as follows:

SECTION V. SEPARABILITY CLAUSE. If for any reason, a part of this Ordinance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

SECTION VI. <u>REPEALING CLAUSE</u>. All previous Ordinances and rules/regulations which are inconsistent with the provisions of this ordinance are hereby deemed, modified or repealed accordingly.

SECTION VII. EFFECTIVELY. This Ordinance shall take effect fifteen (15) days upon its approval and publication in local newspaper circulating in the locality for three (3) consecutive issues and/or posting in at least three (3) conspicuous places in the municipality.
