PREFATORY STATEMENT

Article 231 of the Implementing Rules and Regulations of RA 7160 known as the Local Government Code of 1991 empower the Local Government Unit to levy taxes, fees and charges not otherwise levied by the province.

Likewise, the same code (RA 7160) led to the creation of local economic enterprises whose major purpose is to augment the income of LGU and at the same time support the needs of its local populace.

In conformance with the provisions of RA 7160, the Sangguniang Bayan of this municipality had acted Municipal Ordinance No. 22-13, Series of 2022, dated September 26, 2022 "AN ORDINANCE IMPOSING RENTALS, FEES AND CHARGES OF THE NEWLY ACQUIRED HEAVY EQUIPMENTS OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE", however, this year the LGU Siayan acquired one (1) unit Brandnew XCMG XE210WD HYDRAULIC EXCAVATOR, thus Municipal Ordinance No. 22-13 needs to be amended for its inclusion, hence this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

**"MUNICIPAL ORDINANCE NO. 24-13  
Series of 2024**

**SECTION I. TITLE:** This shall be known as "AN ORDINANCE AMENDING SECTIONS II AND IV OF MUNICIPAL ORDINANCE NO. 22-13, SERIES OF 2022 "AN ORDINANCE IMPOSING RENTALS, FEES AND CHARGES OF THE NEWLY ACQUIRED HEAVY EQUIPMENTS OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

**SECTION II. NEW ACQUIRED HEAVY EQUIPMENTS:** Newly acquired heavy equipments sometimes on the year 2021 to 2024, were as follows:

1. 1 Vibratory Compactor (Pison)
2. 2 Crawler Excavator (Back Hoe)
3. 2 Vargo Trucks 4x2 6 wheelers
4. 3 Dump trucks Isuzu 4x4 6 wheelers
5. 1 Manlift Truck
6. 1 Self Loading Truck
7. Grader AXCM (China)
8. Payloader (Lonking China)
9. Military Truck JAG 6343 SKW
10. Road Roller
11. 1 Hydraulic Excavator XCMG XE210WD

**SECTION III. OLD ACQUIRED HEAVY EQUIPMENTS:** The equipments listed hereunder were acquired sometimes on the year 2018 and 2019, namely:

1. Payloader (Lonking China)
2. Grader AXCM (China)
3. Road Roller (China)
4. 2 Military Truck - JAG 6343 SKW (Komongkomong)

**SECTION IV. IMPOSITION OF RENTALS, FEES AND CHARGES:** That the rates of rentals, fees and charges of the above-named heavy equipments are as follows:

**SECTION V. ADMINISTRATIVE PROVISION:**

- a. That the rental herein impose of the heavy equipment is with operator but excluding oil and lubricants.
- b. That the counting of hours shall commence from the start of its mobilization from the motor pool and/or from the place where the said heavy equipment was pick-up.
- c. That this collection (rentals, fees and charges) is form part of the Municipal Revenue Code.

**SECTION VI. EFFECTIVITY:** This Ordinance shall take effect upon approval of the Hon. Sangguniang Panlalawigan in the Province of Zamboanga del Norte.


