APPROPRIATION ORDINANCE NO. 24-16 Series of 2024

PREFATORY STATEMENT

The Local Finance Committee of the Local Government of Siayan, Zamboanga del Norte had certified that the amount of FOUR MILLION THREE HUNDRED SEVENTY THOUSAND (PHP4,370,000.00) PESOS is actually available from savings of MOOE of various offices.

The programs/projects and activities where the funds had been allocated are no longer priority, hence this enactment;

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This Ordinance shall be known as "APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF FOUR MILLION THREE HUNDRED SEVENTY THOUSAND (PHP4,370,000.00) PESOS INTO UNOBLIGATED BALANCE SOURCED FROM SAVINGS OF MOOE OF VARIOUS OFFICES SUBJECT FOR REPROGRAMMING AND BUDGETING FOR FY 2024 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. REVERSION. That the amount of FOUR MILLION THREE HUNDRED SEVENTY THOUSAND (PHP4,370,000.00) PESOS is hereby reverted into unobligated balance which is free of any encumbrances whatsoever subject to reprogramming and budgeting for various expenditures FY 2024.

SECTION III. EFFECTIVITY. This appropriation Ordinance shall take effect upon approval.
