PREFATORY STATEMENT

WHEREAS, this August body acted MUNICIPAL ORDINANCE 24-12, SERIES OF 2024 - AN ORDINANCE AUTHORIZING THE UTILIZATION AND ALLOCATION PERCENTAGE AND SHARING SCHEME OF PHIL-HEALTH INSURANCE CORPORATION (PHIC) ON REIMBURSEMENT CLAIMS OF RURAL HEALTH UNIT (RHU) OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, Section III of the of the said Ordinance "Legal Basis", Phil-Health Circular No. 013-2024 - the Enhancement of Phil-Health "Konsulta Benefit Package was not included therein.

WHEREAS, on Section 4 thereof, "UTILIZATION AND ALLOCATION PERCENTAGE OR SHARING SCHEME FOR FACILITY OPERATIONAL FUNDS, PROFESSIONAL FEES AND RHU STATIONED PERSONNEL". There are some allocation percentage of RHU personnel and new PHIC program was not specified.

WHEREAS, Sections III and IV of the Municipal Ordinance No. 24-12, Series of 2024 need to be amended, hence this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled.

SECTION 1. TITLE: This Ordinance shall be known as "AN ORDINANCE AMENDING SECTIONS III AND IV OF THE MUNICIPAL ORDINANCE NO. 24-12 SERIES OF 2024- AN ORDINANCE AUTHORIZING THE UTILIZATION AND ALLOCATION PERCENTAGE AND SHARING SCHEME OF PHILHEALTH INSURANCE CORPORATION (PHIC) ON REIMBURSEMENT CLAIMS OF RURAL HEALTH UNIT (RHU) OF LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE AND PROVIDING FUNDS THEREOF".

SECTION II. AMENDMENTS: Section III and IV of Municipal Ordinance No. 24-12 Series of 2024, dated October 7, 2024 are hereby amended, as follows:

A. "SECTION III- LEGAL BASIS" - this Ordinance is enacted in pursuant to the following:

- Phil-Health insurance Corporation Circular No. 2017-0020, subject: Implementation of auto-credit Payment Scheme (ACPCs) to all Health care Institutions.
- Phil-Health Circular No. 014-2014 subject: Revised Guidelines for the Phil-Health Outpatient Anti-Tuberculosis Directly observed Treatment Short-Course (DOTS) Benefit package.
- Phil-Health Circular No. 013-2024 the Enhancement of Phil-Health "Konsulta Benefit Package.

B. "SECTION IV. UTILIZATION AND ALLOCATION PERCENTAGE OR SHARING SCHEME FOR FACILITY, OPERATIONAL FUNDS, PROFESSIONAL FEES AND RHU STATIONED PERSONNEL"

The utilization and allocation percentage or sharing scheme from PHIC are as follows:



SECTION III. SEPARABILITY CLAUSE: That Municipal Ordinance No. 24-12, Series of 2024 is still in effect and enforceable as amended.


SECTION IV. EFFECTIVITY: This Ordinance shall take effect immediately upon its approval.
