MUNICIPAL ORDINANCE NO. 25-04
Series of 2025

PREFATORY STATEMENT

WHEREAS, water is a basic necessity and it is the duty of the local government to ensure an affordable and adequate supply of potable water to all residents.

WHEREAS, recent assessment indicate that the water supply has been significantly strained not only by natural factors such as drought or infrastructural challenges, but also by a notable increase in the number of consumers, which has exacerbated the shortage of the available water supply.

WHEREAS, the strain on the water system has resulted in a reduction of the normal volume of water delivered to consumers.

WHEREAS, it is unjust to charge the consumers with full minimum water tariff when they are not receiving their usual volume of water supply.

WHEREAS, there is a need that water bills shall be adjusted instead of the monthly minimum payment, it shall be based on the actual number of cubic meters consumed, hence this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled, that:

SECTION I. TITLE: This Ordinance shall be known as "**AN ORDINANCE AMENDING ARTICLE E, SECTION 137, (WATER TARIFF FOR LEVEL III WATER SUPPLY) CHAPTER V OF MUNICIPAL ORDINANCE NO. 20-05, SERIES OF 2020 KNOWN AS THE "MUNICIPAL REVENUE CODE".**"

SECTION II. AMENDMENTS: Article E, Section 137, (Water Tariff for Level III Water Supply) Chapter V of Municipal Ordinance No. 20-05, Series of 2020 is hereby amended, as follows:

"ARTICLE E. SECTION 137 - WATER TARIFF FOR LEVEL III WATER SUPPLY".
