APPROPRIATION ORDINANCE NO. 25-05-A Series of 2025

PREFATORY STATEMENT

The Local Finance Committee of the Local Government of Siayan, Zamboanga del Norte had certified the availability of funds in the amount of THIRTEEN MILLION TWO HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED FORTY SEVEN PESOS AND NINETY SIX CENTAVOS (PHP 13,268,347.96) SOURCED FROM SAVINGS OF THE PERSONAL SERVICES OF THE ANNUAL BUDGET FY-2025

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This Ordinance shall be known as "APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF THIRTEEN MILLION TWO HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED FORTY SEVEN PESOS AND NINETY SIX CENTAVOS (PHP 13,268,347.96) SOURCED FROM SAVINGS OF THE PERSONAL SERVICES DULY CERTIFIED BY THE LOCAL FINANCE COMMITTEE EMBODIED IN THE SUPPLEMENTAL BUDGET NO.01 FY-2025 INTENDED FOR SALARY INCREASE OF THE OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE

SECTION II. LEGAL BASIS. This Appropriation Ordinance is enacted in pursuant to the following:

1. Section 4 of Executive Order No. 64 states that Local Government Units may fully adopt Salary Schedule in Section 3 thereof, notwithstanding the above ceilings, subject to compliance with the PS limitation and budgetary authorization requirements of R.A. No. 7160, as well as the guidelines to be issued by the DBM pursuant to Section 7 (d) of RA No. 11964 and its IRR, Provided that the salary schedule adopted shall be uniformly applied to all positions in the Local Government Unit.



- Local Budget Circular No. 160 dated August 12, 2024-Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel; Annex "A-1" First Tranche Monthly Salary Schedule for Local Government Personnel in Special Cities and First Class Provinces and Cities.
 - Section 2 (a) of Republic Act No. 7160, states that LGU's are empowered to provide for the welfare of their constituents through the exercise of genuine and meaningful local autonomy.

SECTION III. AVAILABILITY OF FUNDS. That the amount of THIRTEEN MILLION TWO HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED FORTY SEVEN PESOS AND NINETY SIX CENTAVOS (PHP 13,268,347.96) is hereby available intended for the salary increase of the Officials and Employees of the Local Government Unit of Siayan, Zamboanga del Norte FY 2025. Pertinent papers hereto attached as form part this appropriation ordinance.

SECTION IV. EFFECTIVITY. This Appropriation Ordinance shall take effect immediately upon its approval.
