APPROPRIATION ORDINANCE NO. 25-05
Series of 2025

PREPFATORY STATEMENT

The Local Finance Committee of the Local Government of Siayan, Zamboanga del Norte had certified that the amount of **THIRTEEN MILLION TWO HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED FORTY SEVEN PESOS AND NINETY SIX CENTAVOS (PHP 13,268,347.96)** is actually available from savings of Personal Services (PS) of various offices of the Local Government Unit of Siayan, Zamboanga del Norte.

BE IT ORDAINED BY THE Sangguniang Bayan in session assembled;


SECTION I. TITLE. This Ordinance shall be known as "AN APPROPRIATION ORDINANCE REVERTING THE AMOUNT OF THIRTEEN MILLION TWO HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED FORTY SEVEN PESOS AND NINETY SIX CENTAVOS (PHP 13,268,347.96) INTO UNOBLIGATED BALANCE SOURCED FROM SAVINGS OF PERSONAL SERVICES (PS) OF VARIOUS OFFICES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBONGA DEL NORTE".

SECTION II. REVERSION. That the amount of **THIRTEEN MILLION TWO HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED FORTY SEVEN PESOS AND NINETY SIX CENTAVOS (PHP 13,268,347.96)** is hereby reverted into unobligated balance which is free of any encumbrances whatsoever subject to reprogramming and budgeting for salary increase of the Officials and Employees of the Local Government Unit of Siayan, Zamboanga del Norte for FY 2025.


SECTION III. EFFECTIVITY. This appropriation ordinance shall take effect upon approval.
