A RESOLUTION PASSING AN ORDINANCE PROHIBITING STRAY
ANIMALS, PENALIZING THEM TO PAY THE DAMAGES MADE.

WHEREAS, for the protection of plants, root crops,
buffer crops of farmers, any person or persons raising
livestocks either for working animals or any purpose
should tie their carabaos, cows, horses, goats, swines,
fowls, and the like, properly or keep them inside the
fence, to avoid trouble and destruction of plants of
their co-farmers and or neighbors;

NOW THEREFORE, after due deliberation and on motion
of SB Member Osias D. Cenas, Sr., duly seconded by SB
Member Leonarda M. Zapatos and SB Member Guillermo Pa-
dilla, it was

RESOLVE, as this body hereby resolved, to pass the
following regulation ordinance.

ORDINANCE NO. 15
Series of 1988

AN ORDINANCE PROHIBITING STRAY ANIMALS, PENALIZING THE
OWNER OF SAID STRAY ANIMALS AND REQUIRING THEM TO PAY
THE DAMAGES MADE.

BE IT ENACTED by the Sangguniang Bayan in session
assembled do hereby order as follows:

SECTION 1. that stray animals includes, carabaos,
cows horses, goats pigs/hogs/swine, chickens, ducks,
geese and the like are hereby prohibited.

SECTION 2. that any stray animals mentioned in Section 1 of this Ordinance have damaged the plants, root crops, buffers crops and other plants, ~~any~~ of any body that will generate income of the family, the owner of said animals should pay the equivalent value in cash to the owner of the plants, root crops, buffers crops destroyed.


SECTION 3. Any stray animals cause or inflict damages to plants in private farm or government owned nurseries, caught, shall be impound in a designated place for stray animals, the owner is subject to impoundage fee as prescribed in the existing Municipal Ordinance.

SECTION 4. that any violation hereof, shall suffer to a fines of not less than ONE HUNDRED (P100.00) pesos but not more than FIVE HUNDRED (P 500.00) pesos or imprisonment of not less than 15 days but not more than ONE (1) month or both fines and imprisonment in the discretion of the court.


SECTION 5. that this Ordinance shall take effect 30 days after approval and publication to public places.
