A RESOLUTION PASSING AN ORDINANCE PROHIBITING ANY PERSON USING POISONOUS MATERIALS OR CHEMICALS IN CATCHING FRESH WATER FISH WITHIN THIS JURISDICTION OF SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, it has been observed by this August body, that some persons were using poisonous materials or chemicals such as cyanide and endrine in catching fresh water fish in the rivers and creeks within the territorial bound of this municipality;

WHEREAS, this practices will result to the destruction of aquatic lives in our locality that's very useful to mankind for family consumption, it affect also working animals and the populace using said water;

WHEREAS, through recent findings by the reseachers, it was discovered that aquantity of poisonous chemicals retained inside the body of fish or shrimps that were poisoned;

NOW THEREFORE, after due deliberation and consideration hence on motion of SB Member Apolinario L. Entrina, Sr., duly seconded by SB member Leonarda M. Zapatos, it was

RESOLVE, as this body hereby resolved, to pass the following ordinance.

EXCERPT BE IT ENACTED by the Sangguniang Bayan of Siayan, in Session assembled, do hereby order as follows:

SECTION 1. that any person or persons using poisonous materials, substances and or chemicals specifically, cymbush, endrine and other kinds in catching fresh water fish is hereby prohibited, to protect the aquatic lives away from destruction and to preserve the fresh water from pollution.

SECTION 2. Any violation hereof shall suffer of fines of not less than TWO HUNDRED (P200.00) pesos, but not more than FIVE HUNDRED (P500.00) pesos or imprisonment of not less than FIFTEEN (15) days and not more than two (two (2) months or both imprisonment and fines in the discretion of the court.

SECTION 3. that this Ordinance shall take effect 30 day after approval and copies be furnished to all Barangay Captains, and publication to conspicuous places.
