

SB Min. dated Dec. 8, 1992 cont'd ....

WHEREAS, the distance of the Poblacion to Paranglumba is 2 kilometers while the distance from Poblacion to Domogok is 7 kilometers;

WHEREAS, there is a remaining 3 kilometers for road construction in order to reach the barangay site;

WHEREAS, the farmers of barangay Domogok and traders are in dire need of a road connecting barangay Domogok down to the Poblacion, of Siayan, Zamboanga del Norte where they sell their farm produce and buy things for their daily needs;

NOW THEREFORE, on motion of councilman Crispin Quillopas duly seconded by Councilman Arnulfo Antiquina, it was

RESOLVED, as it is hereby resolved to request the Hon. Ernesto S. Amatong, Congressman of the 2nd District of Zamboanga del Norte, House of the Representatives, Manila, the Honorable Mayor Wilfredo A. Siasico of Siayan, ZN. through the Hon. Sangguniang Bayan of Siayan, Zamboanga del Norte, and the Department of Public Works and Highways (DPWH) to appropriate an amount for the continuation of the construction of the four kilometer CARP funded Paranglumba-Domogok barangay road;

RESOLVED FINALLY, to furnish copies of this resolution to the Honorable Municipal Mayor, Wilfredo A. Siasico, thru the Hon. Sangguniang Bayan of Siayan, Zamboanga del Norte, a copy of the Hon. Ernesto S. Amatong, Congressman of the 2nd District of Zamboanga del Norte, House of the Representatives, Manila, and a copy of the Department of Public Works and Highways (DPWH), for their reference and evaluation, consideration, appraisal and appropriate action.

ORDINANCE NO. 29

AND ORDINANCE PROHIBITING ANY PERSON DESTROYING AND/OR MAKING AN ACT OF VANDALISM TO PUBLIC AND PRIVATE PROPERTIES, PARTICULARLY TO ELECTRIC WIRING CONNECTIONS, AND PENALIZING THOSE VIOLATORS.

BE IT ENACTED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

SECTION 1. An act of vadalism to public and private properties particularly destroying, damaging and distructing electric wirings is hereby prohibited to any person or persons within the territorial jurisdiction of the Municipality of Siayan, Province of Zamboanga del Norte.

SECTION 2. That any violation of this ordinance shall suffer to a fines of not less than ONE THOUSAND (P1,000.00) but not more than FIVE THOUSAND (P5,000.00) PESOS or an imprisonment of not less than one (1) month but not more than six (6) months of both fines and im-


prisonment, depending upon the discretion of the Honorable Court.


SECTION 3. That this ordinance shall take effect Sixty (60) days after approval, publication of copies to all concerned and posting the same to conspicuous places.


Approved unanimously, this 8th day of December, 1992.


There being no further business before the Sangguniang Bayan, thus the regular session was adjourned at 5:00 in the afternoon after a motion of adjournment.


