ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2. SERIES OF 1968, PENALL-ANYBODY COMMITTING ALARM OR PUBLIC SCANDAL, BY INCREASING THE RATE PENALTY, TO THOSE VIOLATORS, IN PURSUANT TO REPUBLIC ACT NO. 7160.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zambo-

SECTION 1. It is declared detrimental to public peace and order and enace to society where a person, or persons shall do any act producing the distrubing and horifying people who are in peaceful quietude or equility, fighting one another in public places, and other acts that scandalous and indicent to the eyes of the public, thus wounding and ing the encarnation of our civilization, and therefore must not be itted to be committed and must be strictly prohibited.

SECTION 2. That any violation of this ordinance shall be fined of less than 7200.00 and not more than 7500.00 or an imprisonment of less than 15 days to one (1) month or both fines and imprisonment in discretion of the Honorable Court.

SECTION 3. That this ordinance shall take effect thirty (30) days ter approval, publication of copies by posting to conspicuous places furnishing copies to all concerned.
