ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2, SERIES OF 1968, PENALIZING ANYBODY COMMITTING ALARM OR PUBLIC SCANDAL, BY INCREASING THE RATE OF PENALTY, TO THOSE VIOLATORS, IN PURSUANT TO REPUBLIC ACT NO. 7160.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte, that

SECTION 1. It is declared detrimental to public peace and order and menace to society where a person, or persons shall do any act producing uproar, disturbing and horifying people who are in peaceful quietude or tranquility, fighting one another in public places, and other acts that are scandalous and indigent to the eyes of the public, thus wounding and tarnishing the encarnation of our civilization, and therefore must not be committed to be committed and must be strictly prohibited.

SECTION 2. That any violation of this ordinance shall be fined of not less than ₱200.00 and not more than ₱500.00 or an imprisonment of not less than 15 days to one (1) month or both fines and imprisonment in the discretion of the Honorable Court.

SECTION 3. That this ordinance shall take effect thirty (30) days after approval, publication of copies by posting to conspicuous places and furnishing copies to all concerned.
