MUNICIPAL ORDINANCE NO. 98-01 Series of 1998

AN ORDINANCE PROHIBITING ANY PERSON OR GROUP OF HERSONS TO CONDUCT OR HOLD ANY DRINKING SESSION OF HARD LIQUUR AT THE CHILDRENS PALY-GROUND VICINITY OF SIAYAN, ZAMBOANGA DEL NORTE AND PENALIZING THOSE VIOLATIONS.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte, in session assembled,

SECTION. 1 TITLE: "PROHIBITION OF ANY PERSON OR GROUP OF PERSONS CON-DUCTING OR HOLDING ANY DRINKING SESSION OF HARD LIQUOR AT THE CHILDRENS PLAYGROUND VICINITY OF SIAYAN, ZAMBOANGA DEL NORTE.

SECTION 2. DEFINITION OF TERMS: When used on this Ordinance, as follows; a. HARD LIQUOR - - - - - Vino or intoxicating brewerage. viz:

- b. CHILDRENS PLAYGROUNDS - An open Air recreation area for children. c. VICINITY - - - - - - Premises, Surpundings, or place nearby.
- d. DRINKING SESSION - - Meeting of two or more persons exclussive for drinking hard liquor.

SECTION 3. DECLARATION OF POLICY: It is the policy of the Local Government Unit of Siayan to preserve cleanliness and orderliness at the Municipal plaza, reservation area for playing and recreation purposes.

SECTION 4. PROHIBITION ACT: No person or group of persons shall be allowed to conduct or hold any drinking session at the childrens playground vicinity, at the public market promises to maintain cleanliness and orderliness to avoid from broken glasses and bottles as presently observed.

SECTION 5. PENAL PROVISION: That any violation of this Ordinance, shall suffer a fines of not less than FIVE HUNDRED (\$500.00) pesos, but not more than ONE THOUSAND (\$1,000.00) pesos and or an imprisonment of not less than FIVE (5) days, but not more than TEN (10) days, or both fines and imprisonment in the discretion of the Honorable Court.

SECTION 6. EFFECTIVITY CLAUSE: That this ordinance shall take effect THIRTY (30) days after approval, publication of copies by posting at the conspicuous places and furnished copies to all concern.
