MUNICIPAL ORDINANCE NO. 98-11
Series of 1998

AN ORDINANCE IMPOSING CURFEW HOURS TO MINORS AGING FROM 18 YEARS OLD AND BELOW
STARTED FROM 10:00 O'CLOCK PM UP TO 4:00 O'CLOCK AM AT SIAYAN, ZAMBOANGA DEL
NORTE.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga
del Norte in session assembled:

SECTION I. TITLE AND SCOPE. This Ordinance shall be known as an Ordinance
imposing curfew hours to minors aging from 18 years old and below started from
10:00 O'clock PM up to 4:00 O'clock AM on the following day at Siayan, Zambo-
anga del Norte. This ordinance shall cover all minors residing, transient or
visitors in this municipality.

SECTION II. DECLARATION OF POLICY. It is the duty of the government to
put control and pass laws for the benefit of minors or youth to lead and pre-
pared them to the good and proper way of life. Imposing curfew hours on minors
will greatly help in minimizing juvenile delinquent and recidivist in the com-
munity.

All minors covering the ages provided herein violating hereof shall be
apprehended and detail in the Municipal Jail. Prior to their release, the pa-
rents should pay the corresponding penalty herein provided and therefore be
turn-over to the Department of Social Welfare and Development (DSWD) for coun-
selling, guidance and other appropriate action. The payment will accrue to the
coffer of the local revenue of Siayan, Zamboanga del Norte.

SECTION III. PROHIBITED ACTS. Minors aging from 18 years old and below
are prohibited to go out for their respective residents, boarding houses, sleep-
ing quarters and the like from 10:00 O'clock PM up to 4:00 O'clock AM.

SECTION IV. EXCEPTIONS. Minors are exempted in the imposition of this
ordinance on the following instances.

(Section IV. Exceptions)


1. Emergency Cases.
2. Minors who are accompanied with their parents/guardians on their way home.
3. Students covering the herein specified ages who attended night school, program/activities. Provided that the aforesaid students are within the premises where the school program/activities held. All students have given a grace time of 30 minutes after the program to go home.
4. Youth affairs.
5. Emancipated minors who have to work date.

SECTION V. PENAL PROVISIONS. Any minors who violates this ordinance shall be penalized in the amount of ₱500.00 pesos on first offense, second offense, ₱1,000.00 pesos and 3rd offense and so forth 1,500.00 pesos.


SECTION VI. EFFECTIVITY CLAUSE. This ordinance shall take effect 30 days after approval and publications, public information and dissemination and posting to conspicuous places.


