"MUNICIPAL ORDINANCE NO. 99-08
Series of 1999

REQUIRING ALL SARI-SARI VENDORS, MARINE PRODUCT PRODUCERS, IMPORTERS, TRADERS,
FOOD OUTLETS, RESTAURANTS AND OTHERS TO TRADE MARKETS AND UTILIZED IODIZED SALT
WITHIN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE AND PENALIZING VIOLATORS
THEREOF.

PREFATORY STATEMENT

Iodine deficiency is the leading cause of preventable mental retardation,
It is a form of "hidden hunger" that goes unnoticed but deprives every affected
individuals in terms of his health, intelligence and economic productivity.
Universal salt iodization is the major solution to improve the iodine status of
our constituents.

The law under RA 8172 known as ASIN LAW mandates that all salt for human and
animal consumption should be iodized. To make more effective in the municipality
of Siayan this Ordinance shall be enforced.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This Ordinance shall be known as "An Ordinance requiring
all Sari-sari vendors, marine product producers, importers traders, food outlets,
restaurants and others to trade/market and utilized iodize salt within the
Municipality of Siayan, Zamboanga del Norte.

SECTION II. REGULATED ACT: To take effect the implementation of this Ordinance,
the following rules and regulations shall be followed:

- a) Sari-sari vendors are hereby required to trade, market iodized salt at
their respective stalls, store and other places where they bargain their
commodities available to consumers. Uniodized salt displayed/sold shall
be seized/confiscated by the local authorities.
- b) Marine product producers are hereby required to used iodize salt in
producing dried fish (bulad) salting fish and other methods of processing.
- c) Food outlets, restaurants carenderias and the like are required to use
iodized salt in preparation of foods, viand and others for human and
animal consumption.


SECTION III. PENALTY CLAUSE. All Sari-sari store/vendors marine products,
restaurants/carenderias, and any food outlets and etc. violated this Ordinance
shall be penalized the amount of ₱200.00 not more than ₱500.00 and in imprison-
ment of 15 days but not more than 1 month and or both upon the descretion of
the court and revocation of business permit.

Ordinance No. 99-08 continued

SECTION IV. EFFECTIVITY CLAUSE: This Ordinance shall take effect after a transitory period of one year after its approval until such time the supply of iodized salt shall be regulated and available in the market and the constituents be familiarized in the transfer of consumption from ordinary salt into iodized salt.




