Section 13, par (c), sub-par (3) of RA 7160 known as the Local Government Code of 1991 empower the Sangguniang Bayan to name or rename public secondary schools hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

**"MUNICIPAL ORDINANCE NO. 20-03**

Series of 2020

SECTION I. TITLE. This shall be known as "AN ORDINANCE NAMING THE SIAYAN NATIONAL HIGH SCHOOL - SENIOR HIGH SCHOOL INTO FELICIANO CASTILLO NATIONAL HIGH SCHOOL".

SECTION II. ORDAINING CLAUSE. That the Siayan National High School - Senior High School is hereby named "FELICIANO CASTILLO NATIONAL HIGH SCHOOL,

SECTION III. EFFECTIVITY. That this Ordinance shall take upon the confirmation of the National Historical Commission of the Philippines, NHCP Building, T.M. Kalaw St., Manila.

**PREFATORY STATEMENT**

Section 76 of Republic Act No. 7160 states that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

The local officials in part of its management and concerned desire to motivate employees by way of promotion to a higher salary grade particularly to those deserving and qualified employees. However, due to financial limitation some positions of a certain office which are no longer necessary are opted to be disbanded and such funding allocation shall be appropriated to the newly created positions.

BE IT ENACTED by the Honorable Sangguniang Bayan in session assembled:

**MUNICIPAL ORDINANCE NO. 30-24**

**SECTION 1. TITLE:** This Ordinance shall be known as "AN ORDINANCE DISOLVING THE POSITIONS OF ADMINISTRATIVE OFFICER IV (INFORMATION OFFICER II) SG 18A, COMMUNITY AFFAIRS OFFICER II SG 18A, BOARD SECRETARY SG 16A AND ADMINISTRATIVE AIDE III (CLERK II) SG 16 IN THE OFFICE OF THE SANGGUNIANG BAYAN SECRETARY AND ADMINISTRATIVE ASSISTANT IV SG 12A, ADMINISTRATIVE ASSISTANT II SG 10A, ADMINISTRATIVE ASSISTANT II (BOOKKEEPER) SG 10A AND ADMINISTRATIVE ASSISTANT I (ACCOUNTING CLERK III) SG 8A, IN THE OFFICE OF THE MUNICIPAL ACCOUNTANT, LIKEWISE CREATING THE POSITIONS OF LOCAL LEGISLATIVE STAFF OFFICER IV SG 16A AND RECORDS OFFICER II SG 16A IN THE OFFICE OF THE SANGGUNIANG BAYAN SECRETARY AND ADMINISTRATIVE OFFICER II SG 16A AND THREE (3) POSITIONS OF BOOKBINDER II SG 7A IN THE OFFICE OF THE MUNICIPAL ACCOUNTANT, AND THE NEW CREATED POSITIONS SHALL BE INCORPORATED IN THE PLANTILLA OF PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF BAYAN, ZAMBOANGA DEL NORTE.
