PREFATORY STATEMENT

The Sangguniang Bayan of this municipality had created the position of **LOCAL LEGISLATIVE STAFF OFFICER IV SG 19/1** in the Office of the Sangguniang Bayan Secretary under Municipal Ordinance No. 20-04, Series of 2020, dated January 20, 2020.

However, upon submission to the Hon. Sangguniang Panlalawigan in the province of Zamboanga del Norte for review, it was learned that the above-mentioned position (**Local Legislative Staff Officer IV**) shall not be under in the Office of the Sangguniang Bayan Secretary but either in the Office of the Municipal Vice Mayor and/or in the Office of the Sangguniang Bayan in pursuant to the Civil Service Commission (CSC) Memorandum Circular No. 22, Series of 2007 subject of such is the "Policies on Primarily Confidential positions in the Local Government Units".

In relation thereto hence this enactment.

"MUNICIPAL ORDINANCE NO. 20-11
Series of 2020

SECTION I. TITLE. This shall be known as "**AN ORDINANCE AMENDING THE CREATION OF THE POSITION OF LOCAL LEGISLATIVE STAFF OFFICER IV (LLSO-IV), SALARY GRADE 19/1 IN THE OFFICE OF THE SANGGUNIANG BAYAN SECRETARY UNDER ORDINANCE NO. 20-04, SERIES OF 2020, DATED JANUARY 20, 2020.**"

SECTION II. AMENDMENTS. That the position of Local Legislative Staff Officer IV (LLSO-IV), SG 19/1 in the Office of Sangguniang Bayan Secretary created under Ordinance No. 20-04, series of 2020 is hereby amended and to be transferred under the staffing pattern and Plantilla of Personnel in the Office of the Sangguniang Bayan of the Local Government Unit of Siayan, Zamboanga del Norte as read: "**AN ORDINANCE CREATING THE POSITION OF LOCAL LEGISLATIVE STAFF OFFICER IV (LLSO-IV), SALARY GRADE 19/1 IN THE OFFICE OF THE SANGGUNIANG BAYAN OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.**"

SECTION III. TRANSITORY PROVISIONS. That some provisions under Municipal Ordinance No. 20-04, Series of 2020 not contrary to this effect shall remain valid, legal and enforceable.

SECTION IV. EFFECTIVITY. That this Ordinance shall take effect upon approval.
