**PREFATORY STATEMENT**

The Local Finance Committee had certified the availability of funds source from the unimplemented projects of the previous budget FY 2019 for the following projects and remained continuing appropriations FY 2020, viz:

1. Capital Outlay (CO)	- 5,269,438.50
2. 20% Development Fund	- 54,130,477.01
3. MDRRF	- 5,212,609.51
4. GAD Fund	- 600,000.00
5. CO (Vice Mayor/SB/MAO)	- 663,498.00
<b>TOTAL =====</b>	<b>PhP65,876,023.02</b>

Nevertheless, the Local Finance Committee had recommended before this august body that such amount shall be declared into unappropriated balance which is subject for reprogramming considering that some projects, programs and activities which were appropriated are no longer priority importance and some which are deemed priority that needs to be continued are minimal and/or insufficient in appropriation, hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

"MUNICIPAL ORDINANCE NO. 20-12-A  
Series of 2020

**SECTION 1. TITLE.** This shall be known as **"AN APPROPRIATION ORDINANCE DECLARING THE CONTINUING APPROPRIATION OF THE PREVIOUS YEAR AMOUNTING TO SIXTY-FIVE MILLION EIGHT HUNDRED SEVENTY-SIX THOUSAND TWENTY-THREE PESOS AND TWO CENTAVOS (PHP65,876,023.02) INTO UNAPPROPRIATED BALANCE FY 2020.**

**SECTION II. ORDAINING CLAUSE.** That the amount of **SIXTY-FIVE MILLION EIGHT HUNDRED SEVENTY-SIX THOUSAND TWENTY-THREE PESOS AND TWO CENTAVOS (PHP65,876,023.02)** is hereby declared into unappropriated balance FY 2020.

**SECTION III. EFFECTIVITY.** This Ordinance shall take effect upon approval.
