PREFATORY STATEMENT

Section 4 of Republic Act (RA) No. 11469 (the Bayanihan to Heal as One Act) granted the President the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic.

In relation thereto, the Department of Budget and Management (DBM) issued Local Budget Circular No. 125, dated April 7, 2020 which is the Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities (BGCM) therefrom the Municipality of Siayan, Zamboanga del Norte was granted in the amount of SIXTEEN MILLION SIXTYFOUR THOUSAND THREE HUNDRED NINETYFIVE PESOS (Php16,064,395.00).

The Local Finance Committee had certified the availability of the above-cited funding source subject for budgeting exclusively used for the COVID-19 related programs, projects, and activities (PPAs) and expenses.

BE IT ODAINED by the Sangguniang Bayan in session assembled:

"MUNICIPAL ORDINANCE NO. 20-15

SECTION 1. TITLE. This shall be known as **"AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF SIXTEEN MILLION SIXTYFOUR THOUSAND THREE HUNDRED NINETYFIVE PESOS (Php16,064,395.00) SOURCED FROM THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) EMBODIED IN SUPPLEMENTAL BUDGET NO. 3 FY 2020.**


SECTION II. AVAILABILITY OF FUNDS. That the amount of SIXTEEN MILLION SIXTYFOUR THOUSAND THREE HUNDRED NINETYFIVE PESOS (Php16,064,395.00) is hereby made available for COVID-19 related programs, projects, activities (PPAs) and expenses. Pertinent documents are hereto attached as form part of this ordinance.

SECTION III. CREATION OF SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF). For easy monitoring/tracking of the utilization of the allocation in the amount of SIXTEEN MILLION SIXTYFOUR THOUSAND THREE HUNDRED NINETYFIVE PESOS (Php16,064,395.00) a Special Account in the General Fund (SAGF) shall be created therefore.

SECTION III. EFFECTIVITY. This Ordinance shall take effect upon approval.
