**PREFATORY STATEMENT**

The Department of Interior and Local Government (DILG) had issued Memorandum Circular No. 2020-071, dated April 9, 2020 directing all Provincial Governors, City and Municipal Mayors, Punong Barangays, members of the Sanggunian, DILG Regional Directors and Field Officers and all others concerned subject of which is the **"MANDATORY WEARING OF FACE MASKS OR OTHER PROTECTIVE EQUIPMENT IN PUBLIC AREAS"**.

Based on the aforementioned DILG Circular, the local government units are enjoined to pass local ordinances, executive orders or advisories the same on the mandatory wearing of face masks to include imposition of sanctions to non-compliant residents.

Such measure was imposed intentionally in preventing further increase in COVID-19 thus wearing of face masks and other protective equipment may reduce risk of local transmissions of the virus hence this enactment.

**"MUNICIPAL ORDINANCE NO. 20-17**

Series of 2020

**SECTION I. TITLE:** This shall be known as **"MANDATORY WEARING OF FACE MASKS OR OTHER PROTECTIVE EQUIPMENT IN PUBLIC PLACES IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE AND PROVIDING PENALTIES OF THE VIOLATORS THEREOF"**.

**SECTION II. DEFINITION OF TERMS:** For purposes of this Ordinance, the following terms shall mean:

- Face Masks – shall mean a protective device that is firmly fastened over the face and covering at least the nose, mouth and chin which serves as protection or barrier against the spread or infection of COVID-19.
- Public Place – shall include all areas in the municipality of Siayan, Zamboanga del Norte that are accessible or open to the public for collective use and enjoyment, regardless of ownerships or right to access including but not limited to offices, restaurants, stores, parkway, playgrounds plaza, hotels, transportation terminals and among others.

**SECTION III. MANDATORY USE/WEARING OF FACE MASK.** All persons are required to wear and use face masks at all times in public places within the territorial jurisdiction of the municipality of Siayan, Zamboanga del Norte during the effectivity of Modified General Community Quarantine.

**SECTION IV.** Any person caught in violation of this Ordinance shall be penalized in the following manner:

First Offense .....100.00

Second Offense .....200.00

Third Offense .....500.00

**SECTION V. IMPLEMENTING OFFICERS.** Members of the Philippine National Police (PNP), Municipal Health Department, Barangay and SK Officials including the members of Tanod and other law enforcers and municipal officials to be determined by the Municipal Mayor, shall implement and enforce this ordinance.


**SECTION VI. REPEALING CLAUSE.** All ordinances, resolutions, rules or regulations which are inconsistent with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.
