**"APPROPRIATION ORDINANCE NO. 20-21
Series of 2020**

PREFATORY STATEMENT

The Local Government Unit of this municipality had appropriated the amount of THREE MILLION (Php3M) pesos intended for CONCRETING OF POBLACION-SITIO PASE, MOYO FARM TO MARKET ROAD (FMR), PHASE 1 authorized under the Economic Development Projects of the 20% development fund of the Annual Budget FY 2020, however, due to COVID-19 pandemic, all LGU's are directed to construct LIGTAS COVID CENTER in compliance with the Health Safety Protocol, likewise the immediate construction of POBLACION-DUMPILAS FARM TO MARKET which also priority importance shall be attained, thus the above-cited funding appropriation necessitates to be realigned hence this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled, that:

SECTION 1. TITLE: This Ordinance shall be known as "AN APPROPRIATION ORDINANCE REALIGNING THE AMOUNT OF THREE MILLION (PHP3,000,000.00) PESOS FROM THE CONCRETING OF POBLACION-SITIO PASE, MOYO FARM TO MARKET ROAD (FMR), PROJECT, PHASE 1, INTO A NEW PRIORITY PROJECT CONSTRUCTION OF LIGTAS COVID CENTER AMOUNTING TO ONE MILLION (PHP1,000,000.00) PESOS AND CONCRETING OF POBLACION-DUMPILAS FARM TO MARKET ROAD AMOUNTING TO TWO MILLION (PHP2,000,000.00) PESOS, AND THE SAME SHALL BE INTEGRATED IN ANNUAL INVESTMENT PLAN (AIP) CY 2020.



RESOLUTION REALIGNING THE AMOUNT OF THREE MILLION PESOS (P 3,000,000.00) PREVIOUSLY ALLOCATED FOR THE CONCRETING OF POBLACION PASE FMR (PHASE I) FROM THE 20% DEVELOPMENT FUND CY 2020 INTO THE CONSTRUCTION OF LIGTAS COVID CENTER AND CONCRETING OF POBLACION TO DUMPILAS FARM TO MARKET ROAD.

Whereas, the Department of Interior and Local Government (DILG) and the Department of Budget and Management (DBM) issued a Joint Memorandum Circular (JMC) No. 01 dated March 27, 2020 enabling the LGUs to undertake critical, urgent, and appropriate disaster response aid and measures to curtail and eliminate the threat of COVID-19;

Whereas, under Joint Memorandum Circular (JMC) No. 01, it provides additional guidelines on the use of the 20% Development Fund (DF) to give the LGUs greater leeway and flexibility in the utilization of funds for disaster preparedness and response efforts to contain the spread of COVID 19, and to continue to provide basic services to the affected population;

Whereas, in view of the necessity to procure the foregoing supplies and services to hasten the development of the municipality, the Municipality's Development Committee deemed it necessary to adopt a measure recommending to this Council for the passage of an appropriate resolution realigning the 20% Development Fund CY 2020 of the municipality;

Whereas, the 20% Development Fund CY 2020 has the following programs amounting to THIRTY EIGHT MILLION SIX HUNDRED THIRTY NINE THOUSAND ONE HUNDRED SEVENTEEN PESOS AND TWENTY CENTAVOS (PHP 38,639,117.20), to wit:


