"APPROPRIATION ORDINANCE NO. 20-24 Series of 2019

PREFATORY STATEMENT

The Local Finance Committee of the Municipal Government of Siayan, Zamboanga del Norte had certified to the probability of collecting the amount of TWO HUNDRED SEVENTEEN MILLION PESOS (Php 217,000,000.00) for the year 2021.

The budget has adequately provided funds for the delivery of basic services and the maintenance of facilities as provided for in Sec. 17 (b) of RA 7160. Statutory and contractual obligations have been provided. Strict observance of AO 103 is encouraged from the different department heads of adhering to the 25% retention on the utilization of Maintenance and Other Operating Expenditures (MOOE) Appropriations. Procurement of good and civil works shall strictly follow the provisions of RA 9184 and its implementing rules and regulations.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This Ordinance shall be known as "APPROPRIATION ORDINANCE AUTHORIZING THE GENERAL FUND ANNUAL BUDGET FY 2021 AND MAKING AVAILABLE THE AMOUNT TWO HUNDRED SEVENTEEN MILLION PESOS (Php 217,000,000.00) FOR THE YEAR 2021 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE EMBODIED THEREIN".

SECTION II. AUTHORITY AND AVAILABILITY OF FUNDS: That the General Fund Annual Budget FY 2020 is hereby authorized and made available amounting TWO HUNDRED SEVENTEEN MILLION PESOS (Php 217,000,000.00) for the year 2021.

SECTION III. SOURCED OF FUNDS. That the funds to cover the General Fund Annual Budget FY 2021 is sourced from the following:

SECTION IV. FUNDING ALLOCATION.

(a) That the amount of PHP 217,000,000.00 is hereby appropriated/allocated for the following expenditures:

- (c) That the budget complied with budgetary requirements and general limitations provided in RA 7160 and its implementing rules and regulations.
- (d) That the execution of this budget shall follow the guidelines and procedure prescribed in the Budget Operations Manual for LGU's and that the disbursements of authorized expenditures shall be based on the approved work and financial plan and the advice of allotment issued by the Local Chief Executive.

SECTION V. USE OF SAVINGS AND AUGMENTATION. In accordance with Section 336 of RA 7160 known as the Local Government Code of 1991, the Municipal Mayor and the Presiding of the Sangguinian concerned may, by ordinance be authorized to augment any item in the approved Annual Budget of their respective offices from savings in other items within the same expense class of their respective appropriations.

SECTION VI. PRIORITY IN THE USE OF PERSONAL SERVICES SAVINGS. Priority shall be given to the personal benefits of local employees in the use of Personal Services Savings.

SECTION VII. CHARGES IN THE MUNICIPAL DEVELOPMENT PLAN AND AIP. In case of changes in the Municipal Development Plan, resolution and decision of the Executive Committee of EMDC is sufficient and executory in order not to delay in the implementation of programs, projects and activities subject of the changes and revisions.

SECTION VIII. STRICT OBSERVANCE OF PUBLIC FISCAL MANAGEMENT POLICIES. That in the utilization of the appropriations in the budget, strict observance of the existing policies on the public fiscal management shall be complied with to ensure frugal expenditures and observance of value of money.

SECTION IX. SEPARABILITY CLAUSE. If for any reason or reasons, any section or provisions of this Appropriation Ordinance is disallowed or declared in valid in budget review by proper authorities, other sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

SECTION X. EFFECTIVITY. This Appropriations Ordinance shall take effect on January 1, 2021.
