### **PREFATORY STATEMENT**

Section 76 of Republic Act No. 7160 states that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

The Sangguniang Bayan of this municipality had acted Municipal Ordinance No. 03-003, Series of 2003, dated March 7, 2003 created various positions and one (1) of these was the position of **HUMAN RESOURCE AND MANAGEMENT OFFICER III (HRMO III) SG-18/1,** duly approved by the Sangguniang Panlalawigan of this province under **SP Resolution No. 738,** dated September 22, 2003, and on July 27, 2020, this august body had acted **Municipal Ordinance No. 20-20,** Series of 2020, the same created various positions and one (1) of these was the position of **ADMINISTRATIVE OFFICER II SG-15/1** duly approved also by the Sangguniang Panlalawigan under SP Resolution No. 223, dated April 6, 2020.

Eventually, the positions herein referred were inconsistently created as to its position title and classifications wherein HUMAN RESOURCE AND MANAGEMENT OFFICER III (HRMO III) is not SALARY GRADE 18 but SALARY GRADE 15 and while the ADMINISTRATIVE OFFICER II is not salary GRADE—15 but only SALARY GRADE—11 based on the UPDATED QUALIFICATIONS STANDARDS FOR CERTAIN POSITIONS per CSC MC and COA issuance that SALARY GRADE—18 is V and SALARY GRADE—15 is 1V on ADMINISTRATIVE POSITIONS hence, this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

### "MUNICIPAL ORDINANCE NO. 21-01

Series of 2021

SECTION I. TITLE: This Ordinance shall be known as "AN ORDINANCE AMENDING THE POSITIONS TITLE AND CLASSIFICATIONS OF HUMAN RESOURCE AND MANAGEMENT OFFICER III, SALARY GRADE 18/1 IN THE OFFICE OF THE MUNICIPAL MAYOR AND ADMINISTRATIVE OFFICER 11, SALARY GRADE 15/1 PURSUANT TO THE CSC MC AND COA ISSUANCE AND THE SAME SHALL BE INCORPORATED IN THE ORGANIZATIONAL CHART AND PLANTILLA OF PERSONNEL OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

**\$ECTION II. AMENDMENTS:** That the following positions are hereby amended in this manner:

### OFFICE OF THE MUNICIPAL MAYOR

 HUMAN RESOURCE AND MANAGEMENT OFFICER 111 SG-18/1 amended into ADMINISTRATIVE OFFICER V SG-18/1 (HUMAN RESOURCE AND MANAGEMENT OFFICER III)

### OFFICE OF THE MUNICIPAL ACCOUNTANT

 ADMINISTRATIVE OFFICER II SG-15/1 amended into ADMINISTRATIVE OFFICER IV SG-15/1

**SECTION III. FUNDING APPROPRIATION:** That the funds for salaries and other emoluments of the position herein amended had been provided and incorporated in the Annual Budget FY 2021.

**SECTION IV. EFFECTIVITY:** This Ordinance shall take effect upon approval in conformance with the government accounting and auditing rules and procedures.

**ENACTED** this 1<sup>st</sup> day of February 2021.
