PREFATORY STATEMENT

The Sangguniang Bayan had acted Municipal Ordinance No. 19-19, series of 2019, dated October 14, 2019 known as Anti-Illegal Structures Construction Ordinance in compliance with the mandate of the DILG in road clearing operations;

For efficient and effective implementation on Anti-Illegal Structures Construction Ordinance acted by the respective municipality, an Awareness Raising Mechanism or Information, Education and Communication (IEC) Activities shall be promulgated, hence this enactment.

BE IT ENACTED by the Sanggunian Bayan in session assembled:

"MUNICIPAL ORDINANCE NO. 21-03 -A
Series of 2021

SECTION 1. TITLE. This shall be known as: **"AN ORDINANCE PROVIDING AWARENESS RAISING MECHANISM IN THE IMPLEMENTATION OF MUNICIPAL ORDINANCE NO. 19-19 - ANTI - ILLEGAL STRUCTURES CONSTRUCTION ORDINANCE".**

SECTION II. AWARENESS RAISING MECHANISM OR INFORMATION, EDUCATION AND COMMUNICATION (IEC) ACTIVITIES.

- 1.1 Posting of Notices, Signboards and Signages along strategic sites of the National Highway within this municipality, showing among others, the prohibition against road obstructions (i.e. illegally parked vehicles, illegal structures along public roads), the legal basis for the prohibition and the corresponding penalty for its violation.
- 1.2 Posting of Municipal Ordinance No. 19-19 in the LGU's website and other social media outlets.
- 1.3 IEC information drive during barangay assemblies, Liga Meetings and other fora;


SECTION III. IMPLEMENTATION. The Municipal Road Clearing Task Force shall implement the provisions of this ordinance by tapping the services of the Municipal Engineering Office in the installation of the signages. Members of the Task Force shall also conduct IEC on the Anti-Road Obstruction Ordinance on the occasion of barangay assemblies, Liga Meetings, and other forum.

SECTION IV. EFFECTIVITY. This ordinance shall take effect upon approval.
